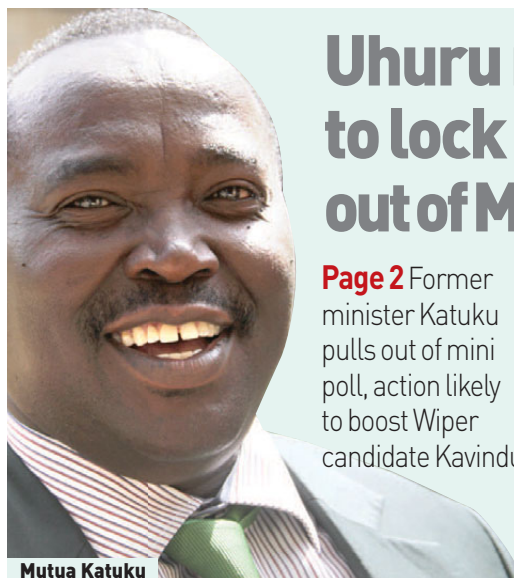

DP's hand in Kuria bid to front aspirant for Juja by-election

The People's Empowerment Party (PEP) associated with Gatundu South MP Moses Kuria appears to be a proxy to Deputy President William Ruto for the Juja by-election.

The party is fielding George Koimbur, considered as one of the serious contenders in the mini poll, after ditching the ruling party Jubilee for (PEP) last Sunday. Kuria's party has already settled for Koimbur, who came second in the 2017 Juja constituency election.

Koimbur is one of the more than 10 aspirants for the seat that fell vacant following the death of Francis Munyua Waititu 'Wakapee'. The by-election is slated for May 18.

The United Democratic Alliance (UDA) associated with the DP abruptly pulled out of the race after initially indicating it would sponsor a candidate, only for Kuria's party PEP to give its ticket to Koimbur. Kuria is one of Ruto's close allies. Reached for comment, the outspoken MP who

represents President Uhuru Kenyatta's rural home constituency said he is not fronting anyone in the Juja by-election and that he is only trying his luck in politics.

"People may say anything, but I will let them be. I am only advancing my party and my agenda. Hii ni soko huru (this is democracy)," Kuria said when asked whether his decision doesn't bring him on a collision course with the President with Juja considered as a gateway to his rural home.

Waititu's widow, Susan, will now face off with at least three other aspirants for the Jubilee party ticket in primaries scheduled for Saturday.

Other contestants eyeing the Jubilee ticket are Naftaly Rugara Muiga, a lecturer at Jomo Kenyatta University of Agriculture and Technology, former Kiambu Education Minister Joseph Ng'ang'a and businessman Anthony Kirori.

The rest are independent aspirants among them 32-year-old medical doctor Joseph Gichui who is the youngest in the crowded race.

Uhuru moves to lock Ruto out of Machakos

Wiper senatorial candidate withdrew from the race, a day to the by-election slated for tomorrow

Machakos senatorial candidate Mutua Katuku yesterday pulled out of the race, barely two hours after President Uhuru Kenyatta held a virtual meeting of the leading political party leaders, during which issues around tomorrow's mini-poll were discussed.

The dramatic withdrawal by Katuku, a day to elections, is likely to be a major boost for Wiper candidate Agnes Kavindu, who will be running against Urbanus Ngegele of the United Democratic Alliance (UDA) that is associated with Deputy President (DP) William Ruto.

Yesterday's meeting brought together ODM leader Raila Odinga, Kalonzo Musyoka (Wiper), Musalia Mudavadi (ANC), Narc's Charity Ngilu, Ford Kenya's Moses Wetang'ula and Gideon Moi of Kanu.

The Big Seven have closed ranks in support of Kavindu, in a move that is meant to stem Ruto's efforts to make inroads in Ukambani, which is Kalonzo's backyard as well as confront his defiance of the President.

A statement by the State House spokesperson said the leaders discussed the surge in Covid-19 infections in the country and asked all politicians to lead in observing health protocols to prevent further spread of the disease.

Divisive politics

"In light of the above, the meeting, the President urged all their political affiliates and supporters, especially in Machakos, to find a peaceful, amicable and uniting way forward during the upcoming by-elections," said State House spokesperson Kanze Dena.

The meeting was convened as a follow-up to the one held on February 25, to review the surge of Covid-19 infections across our nation.

The meeting considered the evolution of Covid-19 disease within our borders and noted with concern that Covid-19 infections were increasing at an alarming rate.

Addressing the press after Katuku's surprise move, Maendeleo Chap Chap party leader Alfred Mutua, who was flanked by the candidate, former Machakos county Woman Representative Susan Musyoka and Yatta MP Charles Kilonzo, said the decision was in line with President Uhuru's call for friendly political parties work together in the forthcoming by-election.

Mutua said time had come to end the culture of divisive politics which have in the past been governed by the winner-

take-all culture.

"Regarding Machakos, we believe our candidate has the best chance to clinch the Senate seat. Maendeleo Chap Chap party supported the re-election of President Uhuru and in the spirit of consistency, we support his development agenda and the political stability of the nation," said Mutua.

"In this regard, so as to ensure that the national unity agenda succeeds, and that detractors such as UDA, do not get an opportunity to roll back the achievements so far, Maendeleo Chap Chap party extends goodwill to the President, to Raila Odinga and other BBI partners by withdrawing its candidate from the forthcoming by-election," he said.

And Katuku told *People Daily* that the decision had been reached on Uhuru's request.

The Machakos seat fell vacant after the death of Boniface Kabaka.

Kalonzo, Mudavadi, Moi and Wetang'ula last Friday pitched tent in the county to drum up support for Kavindu.

Yesterday's meeting between Uhuru and the party leaders was a follow up to the February 25 talks, where the President

met the leading politicians to discuss ways to roll out joint countrywide tours to drum up support for the Building Bridges Initiative (BBI).

After the meeting at State House, Nairobi, Moi read a joint statement affirming their commitment to the constitutional changes envisaged in the BBI.

"To this end we shall hold a joint consultative meeting on the March 9, 2021, involving Members of Parliament and counties leadership," Moi stated then.

Apart from Covid 19 infections and the Machakos by-election, sources close to some of the party leaders revealed that yesterday's meeting also discussed the BBI Bill that is before the Senate and National assembly and which is currently undergoing public participation.

Very fruitful

DP Ruto was once again missing in action, just like it happened during the previous meeting. When contacted yesterday, Mudavadi confirmed that they participated in the virtual meeting.

"We heard a virtual meeting, a very fruitful one, the statement from the presidential spokesperson accurately captures what transpired," he said without divulging further details.

During the virtual meeting, the leaders also raised concerns that hospital beds especially Intensive Care Unit (ICU) beds, were filling up in public and private hospitals.

"The meeting considered the evolution of Covid-19 disease and urged Kenyans to remain on high alert, to exercise extreme caution and be aware of the Covid-19 reality and to do their utmost to observe all Covid-19 protocols. It urged all political players to take the lead in the observation of Covid-19 protocols," the statement added.

Groups back constitution change, urge Parliament to pass BBI bill

Wiper Party yesterday led Mau Mau war veterans, women, youth and students groups in throwing their weight behind the Building Bridges Initiative (BBI) sponsored Constitutional Amendment Bill urging Parliament to approve it.

They backed the proposed constitutional changes saying the bill will fix the perennial challenges the country has grappled with for decades.

"We support this bill as it is and we ask, of course, Kenyans to pass it when it is put before them in the referendum," the party's vice chairman Victor Swanya said.

Swanya told the joint commit-

tee co-chaired by Nyamira Senator Okong'o Omogeni (Nyamira) and Kangema MP Muturi Kigano that the proposal to introduce Ward Development Fund was progressive as it would cascade development down to the ordinary people.

Separately, the Linda Katiba lobby opposed the bill terming it a threat to the transformative promise of the 2010 constitution.

Led by Cindy Mwendwa, the group said the proposed changes to the constitution does not seek to solve the problems that have bedeviled the country and persists including corruption, human rights abuses, marginalisation, and exclusion.

"We take this opportunity of public participation to record for posterity

that the constitution amendment bill 2020 currently before parliament is unconstitutional, illegitimate a travesty of justice and an insult to the intelligence of Kenyans," they said in a memorandum to Parliament.

"In considering this bill, Parliament is aiding and abetting the same. In view of the foregoing, we urge Parliament to heed the advisory come to its sense and suspend any further action on this bill," they added.

However, Mau Mau War Veterans Association urged MPs and Senators to pass the bill saying it will cultivate and develop unity among Kenyans.

"BBI will create love and helpfulness among the people of Kenya without nepotism and make Kenyans live in harmony," Gitu Kahengeri, the

group's secretary said. Young Women for Kenya (YOWK) also backed the bill saying the proposal to increase the number of senators from the current 47 members representing each county to 94 senators will be a game changer for mainstream representation and promoting gender equality and women empowerment agenda. Each county will be represented by two senators, one woman and one man.

Led by its founder and chairperson, Sasha Wamae, they argued that the inclusion of women in the Senate means that they will be part of key decision making on resources allocations and go ahead to oversight as opposed to running a women representative docket that have less impact.

How five Odinga family members battled Covid

EALA lawmaker Oburu Oginga says family's resilience and trust in God has seen them overcome the deadly disease

The Odinga family is still reeling from the ravages of the Covid-19 pandemic, which has struck five family members in the last five months.

The latest to be affected by the disease is the family's most famous son, Orange Democratic Movement (ODM) party leader Raila Odinga, who was last week taken ill and admitted to the Nairobi Hospital for five days.

Raila's sudden illness and hospitalisation sent shockwaves across the country, forcing him to come out and issue a public statement assuring his supporters that all was well.

In a candid interview with *People Daily* yesterday, Raila's elder brother and the Odinga family spokesman Dr Oburu Oginga, opened up on how the pandemic had ravaged the family of the late doyen of opposition politics, with at least five members being hospitalised since last October after contracting the disease.

According to Oburu, an East African Legislative Assembly (Eala) MP, himself, his sister Ruth Odinga, his son and Raila have at one time or another over the last five months been hospitalised suffering from the disease.

One other family member, whom Oburu declined to name, is currently in isolation after contracting the virus.

Yesterday, Oburu revealed how the family's resilience and trust in God has seen them overcome the deadly disease.

Big delegation

Oburu narrated how he had tested positive soon after the much-publicised meeting with elders from the Kikuyu community who had visited the Odingas at Kang'o Ka Jaramogi in Bondo, Siaya County, in October last year.

"We had a big delegation that came to our home to cement the relationship between the Kikuyu and the Luos. We had a good meeting and exactly a week after

the elders left I felt sick and when I went to hospital I tested positive for Covid-19," Oburu narrated.

He said even though he was calm, members of his family including Raila were shocked at the news.

"You know it is a strange disease and going by what had been in the news then, my family members were shocked but we had faith that we would overcome it," he said.

By some twist of fate, Oburu was admitted to Nairobi Hospital and coincidentally, in the same ward where his younger brother Raila spent five days last week.

Oburu said: "I was very confident that I would overcome it because to me it is just like any other disease. In fact, many people die of other diseases everyday so it was just normal."

Regular exercises

He said his symptoms were not severe even though most of his family members were worried. In total, Oburu spent two weeks in the hospital.

"Mine was kind of asymptomatic but I had faith that I would overcome it and here I am and by the grace of God I feel strong," he said. A couple of weeks later, one of his sons, whose name he declined to disclose, also tested positive for Covid-19.

"Immediately after my case, my youngest son also felt sick and when he went to hospital he tested positive and had to be isolated for some time. And luckily he also survived and is now back on his feet," said the veteran politician.

Since he was discharged from hospital, Oburu said he ensures he does his regular exercises and minds his diet. Occasionally he plays golf at the Nyanza golf club to burn some calories.

"I play golf not to become a professional golfer but because it's a good exercise opportunity for me; at my age I need to be physically fit," he said.

Oburu's younger sister Ruth, who served as the Kisumu deputy governor between 2013 and 2017, also exhibited Covid-19 symptoms and was admitted for three days at the Nairobi Hospital before being discharged.

Ruth said: "I was losing breath and had a severe headache. I was surprised, however, when my results turned negative and I even wondered how because all the symptoms were similar to those of Covid-19."

"I was ready to go public because I had

faith that I would overcome the disease. Since then, I have been praying because to me it was a miracle that I had the same symptoms but tested negative."

People Daily established that another member of the Odinga family is currently in isolation after testing positive.

"It is true one of the members apart from Raila is also in isolation but because of the sensitivity of the matter, I cannot mention the name," said the source who requested anonymity.

Oburu encouraged Kenyans who have tested positive for Covid-19 to go public about their experience as part of the fight against stigma around the disease.

"For me, I fear nothing, that is why I am confident of saying I had Covid-19. It's just like any other disease but because it is a strange one, people fear talking about it," the MP said.

Doctors guidelines

He added that the family was "shocked to the core" by Raila's revelation last week that he had contracted the disease.

"I was shocked because I was with him a day before and he was in high spirits and I even told him he looked bright. When the results came out it was a shocker to me and the entire family."

Raila was discharged at the weekend after spending five days at the Nairobi Hospital. Prior to his admission, Raila had

Police pursue domestic tie in NLC boss' gruesome murder

Report indicates Jennifer Wambua was aware of threats to her life but she did not report to authorities or confide in kith or kin

Detectives are investigating the possibility of a family dispute or a deal gone sour in the gruesome murder of senior National Land Commissions (NLC) Deputy Director of Communication Jennifer Wambua.

NLC Chairman Gershom Otachi has mourned Ms Wambua, saying: "On behalf of the commission, I wish to send our heartfelt condolences to the husband, children, family and friends of the late Jennifer Wambua."

Ms Wambua's body was discovered in Ngong Forest and taken to the City Mortuary on Saturday, a day after she went missing from her workplace hours after her husband had dropped her.

But it was not until Monday that it was identified by her husband, Joseph Komu.

The Homicide and Crime Scene Investigations detectives from the DCI headquarters yesterday visited the scene in what is commonly referred to as scene re-enactment in a bid to establish the route and weapons used by Ms Wambua's murderers and to recover any exhibits. All these were documented.

According to preliminary reports, the deceased knew some people were after her life but neither reported to the police nor any close confidant.

Broadened scope

Detectives have now broadened the scope of the probe to include possible family angle or a deal gone sour.

"From the preliminary investigations, the deceased knew she was living on borrowed time, but she never reported to the police nor confided in a close relative," a senior detective said.

At the same time, preliminary probe into the March 6 accident in which the deceased was involved in within Machakos have also not established any link to the killing. Records at the Machakos Police Station indicate that both vehicles were headed the same direction but Ms Wambua was to blame for the accident.



"She left her lane and hit the rear left tyre of the vehicle in front. According to our reports, she suffered minor injuries," an officer told *People Daily*.

Investigators yesterday said the deceased could have deliberately left her phone in the family car that had been used by her husband to drop her at work on the Friday she went missing, further complicating the probe.

A call data analysis is expected to be conducted in a bid to find out the people she communicated with before she went missing. Detectives have also obtained a CCTV footage that captured her last movements for analysis, especially from her office in Upper Hill. The detectives said they intend to record statements from Ms Wambua's husband, a guard at the Hill Plaza where the vehicle was parked, the herder who discovered the body and the officers who first visited the scene among others.

Ms Wambua had actually left her personal belongings in the family car that fateful Friday morning. According to the detectives, the missing official's mobile phone, handbag and packed lunch were found in the car.

The probe will involve analysis of the CCTV footage obtained from the NLC offices at the Ministry of Lands Ardi House headquarters, which indicated that Ms Wambua left the office carrying nothing, and alone, around 10am.

VITAL DETAILS

The husband said he dropped the wife at around 7am before he proceeded to his place of work at Kilimo House, the Ministry of Agriculture headquarters.

He later went to NLC offices where he learnt that his wife had left the office located on the fourth floor, earlier. Her office door was locked. Komu said he got concerned when he tried reaching his wife during the day in vain. He however did not panic. "We speak a lot and regularly but on that day I called around 10am the calls went unanswered," he told the police.

Deceased husband

The body had been taken there by officers from Ngong Police Station on Saturday March 13 and given admission number 502/21. Wambua's husband had earlier reported the matter at Capitol Hill Police (OB number 14/13/3/2021)

On Monday at around 3pm, detectives from the Kilimani DCI visited the morgue, accompanied by the deceased husband, where the body was positively identified.

"At the mortuary, the body was positively identified as that of Jennifer Tumbi Wambua by her husband who had earlier reported the incident. The body had injuries and bruises," Kilimani DCI boss Fatuma Hadi said.

The autopsy was scheduled to be conducted yesterday but was changed to a later date, possibly today.

Two families fight over burial rites of teacher

Two families in Kisii Central sub-county are embroiled in a court battle on who has the right to bury Nancy Kemunto, a secondary school teacher, who died last month.

Kemunto's body has been lying at the Kisii Teaching and Referral Hospital morgue.

Her husband, Bob Chweya, has sued his father-in-law, Evans Keera and brother-in-law, Cliff Moses and is seeking orders to allow him bury the wife at his home in Bobaracho in the outskirts of Kisii town. Through lawyer Lazarus Mose, Onkoba says the two have denied him a chance to take part in Kerubo's burial arrangements, arguing he had not paid dowry.

Keera, through defence lawyer Philemon Ochwangi, told Kisii Resident Magistrate Ezekiel Obina that Onkoba has been cohabiting with Kemunto since 2009 and sired two children. She was a teacher at Masongo Secondary School. He told the court that since the son-in-law never paid dowry, there was no marriage and therefore, he should be allowed to bury his daughter at his home in Nyaura.

"The contestation by the father-in-law that there is no marriage is a fallacy and misleading the court. Non-payment of dowry does not nullify a marriage," protested Onkoba.

According to his lawyer, Onkoba a pharmacist, and Kemunto have lived as wife and husband for 11 years and have portrayed themselves so, adding they should be treated the same even in death. "In cases where dowry has not been paid traditionally, it can be done and burial carried on without hitches. Onkoba should be allowed to bury his wife," said the lawyer.

But Keera's lawyer had told the court that, according to her family, Kemunto was not married and wondered why someone could claim to be her husband. He argued the family does not know Onkoba and has never visited the family.

Lawyers from both sides will make their final submissions today.

Gachagua files defence in Sh1.5b contested land case

Mathira MP Rigathi Gachagua now claims a Sh1.5 billion property near Jomo Kenyatta International Airport (JKIA), being contested by a former director of Physical Planning, belongs to him.

Gachagua, through lawyer Philip Nyachoti, claims he bought the property in 2012 at Sh24 million.

He says the National Lands Commission investigated the dispute and found the land belonged to him.

"The decision by the commission is still in full force and therefore binding, in the circumstances the matter cannot be ventilated afresh before this court while the said decision by commission subsists," he said in court documents. The MP says the land was allotted to Karandi Farm Ltd, owned by Peter Nduati and Pauline Muringe and who paid Sh54,000.

The couple later approached the MP's firm, Wamunoro Investment Ltd, where they sold it to him at Sh24 million in June 2012.

Case will be heard on June 7.

Officer in custody over man's death

A Mombasa-based General Service Unit officer drawn from the special force, Recce Company, has been arrested for allegedly murdering a gym instructor.

Directorate of Criminal Investigations officers from Kisauni sub-county trailed the suspect, Kirimi Gikangu, to his hideout at Kaeleo area in Meru County.

Police reports say the suspect is believed to have murdered Allan Gicharu at Mondana area in Kisauni sub-county on February



2, following a love affair between the instructor and the officer's wife.

Gikangu, who is currently attached in Boni Forest, had gone into hiding following the murder, alongside his wife, who is yet to be arrested.

Police investigations revealed

that the suspect had invited the deceased into his house where they began partying.

"The suspect invited the deceased to his house where they drank beer and after a few hours, the deceased was too drunk to leave the house. The suspect asked him to sleep on the couch, and as he slept, he hit him with a metal rod and later stabbed him several times leaving him to bleed to death," the report.

Reports further indicate that the suspect is being ferried to Mombasa from Meru to face murder charges today.

State assures on security, coronavirus measures as exams start

The Government yesterday assured that it's now all systems go for administration of national examinations, with Kenya Certificate of Primary Education (KCPE) exam rehearsals set for Friday.

Government Spokesperson, Colonel (Rtd) Cyrus Oguna said all arrangements had been made and measures put in place for effective and successful administration of the exams, assuring that no one will miss out because of school fees balances or other circumstances such as insecurity.

He also said integrity of the exam process has been upheld and that exams will be taken under strict adherence to Covid-19 protocols, including sufficient spacing, frequent use of sanitizers and handwashing, for the wellbeing of learners and teachers.

"Examination centres have been established across the country, including areas like Kapedo and Merti that have been experiencing security challenges. Even students whose schools were affected by the rising lake waters in areas like Baringo County will sit for exams in centres where they had been transferred to," Oguna said yesterday, in

a press conference in Nairobi. All other classes, from Pre-Primary 1 to Class 7 and Form 1 to 3 are expected to have closed by tomorrow to pave way for a conducive examination environment.

Well-prepared

Oguna said management of examination is a multi-agency activity that brings together different agencies and stakeholders, with the sole purpose of ensuring success and efficiency during exam period.

He said that among the infrastructure set up include the establishment of command and control centre to facilitate ease of communication and response during the

examination period. Oguna also assured that necessary logistics have also been put in place to ensure that exams activity goes on uninterrupted, adding that the examinations shall be conducted under strict adherence to Covid-19 protocols.

Oguna also acknowledged teachers who have worked, sometimes under very difficult circumstances to prepare candidates for the exams. The Kenya National Examination Council (KNEC) registered 1,191,725 candidates in 28,467 KCPE examination centres while 752,981 KCSE candidates have been registered in 10,437 examination centres.



Uhuru appoints Kembi to chair CA board

Kenya Medical Supplies Authority (Kemsas) board chairman Kembi Gitura has left the agency to head the Communications Authority of Kenya board.

President Uhuru Kenyatta has appointed the former Murang'a Senator to chair CAK board for a period of three years with effect from April 18, 2021.

Gitura has been at the helm of the authority for barely two years during which the board was dogged with numerous scandals, the latest one being the loss of billions of shillings in the supply of Covid-19 related materials.

Gitura, however, maintained that no money was lost but went ahead and suspended three top officials including Chief Executive Jonah Manjari, Director of Procurement Charles Juma and Commercial Director Edward Mureithi.

During one of the appearances before a parliamentary committee, Manjari claimed that some board members influenced the award of the Sh7.6 billion Covid-19 related tenders.

Manjari said contrary to claims that the board members were not aware of what was going on at the institution, they were briefed on a day to day basis though no physical meetings were being held due to upsurge of coronavirus cases.

Yesterday, acting Chief Executive Edward Njoroge said he was not aware of a new board being formed. "I have heard of the Gazette Notice but no more details have been availed to me. I will respond after I receive the brief," he said.

Lawmakers propose tough rules for surrogate mothers

Debate on Assisted Reproductive Technology Bill 2019 expected to start once MPs, who are on recess, resume sittings on Tuesday

Women who agree to carry a pregnancy for another woman, popularly known as surrogate mothers, must be at least 25 years old and must have given birth to at least one child before entering the agreement.

Also, a surrogate mother who consents to carrying a child on behalf of interested parties to a marriage or couple shall not terminate the pregnancy or have any rights over the child once born.

She shall also be barred from contacting the couple after the birth of the baby as she would have relinquished all parental rights over the child at birth. These are some of the far-reaching amendments to the Assisted Reproductive Technology Bill 2019 currently in the National Assembly.

The amendments stipulate that couples intending to get a child through the method compensate the surrogate mother for the process of In Vitro Fertilisation (IVF), insurance cover in case of any acts that may lead to death or disability, antenatal care, birth, post-natal care and post delivery care in case of complications.

Performing the procedure

The amendments have been sponsored by the National Assembly's Health committee chaired by Murang'a County Woman Rep Sabina Chege. The Bill, which is sponsored by Suba MP Millie Odhiambo-Mabona, was introduced in the National Assembly in March 2019.

"A woman of 25 years or more, who has given birth to at least one child and who understands the rights and obligations accruing under surrogate agreement, may at the request of the couple consent to a process of assisted reproduction for purposes of surrogate motherhood," reads a proposed amendment to the Bill.

Debate on the Bill is expected to start once MPs who are on recess resume sittings on Tuesday next week. A similar Bill, known as the Reproductive Healthcare Bill, 2019, sponsored by Nakuru Senator Susan

Kihika, is also currently being debated in the Senate.

The Senate Bill, which advocates for "legal and accessible safe abortion", adolescent-friendly "family planning" services, surrogacy, test-tube babies and even comprehensive sexuality education for children, has been opposed by the Ministry of Health, the Church and Non-Governmental Organisations (NGOs).

Sabina's committee has proposed that an assisted reproductive technology expert licensed by the Assisted Reproductive Technology Directorate, not an ordinary medical doctor, should be the one to perform the procedure. The proposed directorate will have powers to develop standards, regulations and guidelines on assisted reproductive technology.

It will also have powers to advise the Health Cabinet Secretary on matters relating to the treatment and care of persons undergoing assisted reproductive technology.

Legislators proposed that fines not exceeding Sh5 million, imprisonment for a term not exceeding five years, or both, be imposed not only on those who commercialise the procedures but those who perform the surgery without seeking consent of the parties involved.

The MPs, however, raised concern that the Bill lacks sufficient provisions to deal with pertinent issues arising from the procedure such as provision of commercial surrogacy and compensation mechanisms to ensure the service is not exploitative.

In case of the death or incapacity of any of the parties, the amendments state that

the assisted reproductive technology clinics and assisted technology banks should not preserve any human embryos without specific instructions and consent in writing from all the parties seeking the said services.

"An assisted reproductive technology expert shall obtain prior informed and written consent from the parties before providing any assisted reproductive technology service under this Act or any other law," states the amendment. The amendments propose that the commissioning couple will be the legal parents of the child born under the surrogacy agreement and will not discriminate against him or her.

In case of multiple pregnancies arising out of a surrogacy agreement, the MPs were categorical that all the children born out of the pregnancy shall belong to the commissioning parents and the rights and obligations for all parties shall vest as if the pregnancy had borne only one child.

But the commissioning parents shall not in any way terminate the consent agreement after the transfer of embryos into the womb of the surrogate mother; the amendments propose.

Legal rights

The committee, however, says there is need to amend Section 11 of the Births and Death Registration Act to be aligned to the Bill to allow registration of children born of assisted reproduction by the commissioning parents, as, currently, registration can only be undertaken with the surrogate mother, a move that has posed great challenges as the biological parents have to undertake a legal adoption process to be registered as parents.

"A child born out of assisted reproductive rights shall have the same legal rights under the Constitution or any other written law as that of a child born through sexual intercourse. The health and well-being of the children born through the application of assisted human reproductive technologies shall be given priority in all decisions," reads the amendment.

For a surrogacy agreement to be valid, the MPs proposed that it must be in writing and should include provision for the contact, care and general welfare of the child. It should also be signed by two witnesses from each of the parents as well as state what happens in case of death or divorce of the parents.

Kemri boss defends move to roll out Corona vaccination

Samuel Kariuki says jab had proven efficacy and safety for use after its trials in phases one and two

The Oxford-AstraZeneca vaccination drive is concurrently going on with its phase three clinical trials, Kenya Medical Research Institute (Kemri) acting Director General Prof Samuel Kariuki said yesterday.

Speaking after receiving the jab at Mbagathi Hospital, Kariuki defended the government's move to roll out vaccination before completion of clinical trials.

"The vaccine has successfully passed through two clinical phases. Now we are at phase three, which has shown high efficacy against Covid-19. It, however, has minor side effects that include slight headache and loss of appetite that do not require medical attention," said Prof Kariuki.

Kemri boss also revealed that in collaboration with Oxford University among other research institutions, Kenya has played a critical role in this vaccine development.

Trial phase of the vaccine, developed by the University of Oxford in partnership with the pharmaceutical company AstraZeneca, started last year and conducted by the Kemri-Wellcome Trust Research programme in Kilifi.

Clinical development is a three-phase process. During Phase I, small groups of people receive the trial vaccine.

Clinical study

In Phase II, the clinical study is expanded and vaccines are given to people who have characteristics (such as age and physical health) similar to those for whom the new vaccine is intended.

In Phase III, the vaccine is given to thousands of people and tested for efficacy and safety. "The reason we have rolled out the vaccine before the final clinical trials is because other trials have been successful. Also, the directive by the World Health Organisation as an emergency roll out due to the pandemic," said the Prof.

On the safety of the vaccine to those being vaccinated, Kariuki exuded confidence, saying there is no cause for alarm.

Countries including France, Denmark,

Ireland and Thailand have temporarily suspended use of AstraZeneca's vaccine after reports that some people developed blood clots, although there is no proof that it was as a result of the shot.

So far, over 10,000 healthcare workers and other frontline staff have been vaccinated.

At the same time, Embu Governor Martin Wambora has urged residents to continue observing the laid down health protocols to cushion themselves against the upsurge in cases of Covid-19 in the third wave being experienced in the country.

While receiving the vaccine at Embu Level Five Hospital, Wambora expressed confidence in it.

The county boss, who is also the Chairman of Council of Governors, said the county bosses resolved to be on the forefront in receiving the vaccine to set example to their constituents.

In Kwale, Health Executive Francis Gwama said medics from private and public health facilities will be given first priority.

"We have so far trained 200 health care workers who will administer the jab. We have equipped them with skills and Personal Protective Equipment to make their working environment safe and conducive" he said. The second and third groups to benefit are teachers and police officers. Speaking at Msambweni Referral Hospital, Gwama noted that the vaccine will be

issued on a voluntarily basis but it is important for each of them in three groups to get the vaccine.

Closed temporarily

"We will not force anyone to go for the vaccine but it is important that health workers, teachers and police officers get it as the nature of their work exposes them to a lot of people," he continued.

Meanwhile, the Kwale County Assembly has temporarily been closed for fumigation after five Ward Reps tested Corona positive. In a statement, the Speaker Sammy Ruwa said they have suspended all sittings and gatherings for 14 days.

And in Kiambu, Governor Dr James Nyoro and his deputy Dr Joyce Ngugi have finally been vaccinated against Covid-19 at the Kiambu Level Five Hospital.

Speaking after he received the jab, Nyoro encouraged other residents, and particularly health workers to take the jab.

The governor dismissed raging negative talks about the vaccine. "There has been a lot of discussions from the public with some doubting the efficacy of the vaccine, but the bottom line is that it is safe," he said. He urged the priority groups to consider taking the vaccine, saying it was safer to be vaccinated than to contract Covid-19, which is extremely costly to treat.

Seven deaths as 1,016 test positive for deadly virus

The number of new Coronavirus cases recorded in a day has crossed the 1,000 mark as the third wave continues to wreak havoc across the country.

Health Cabinet Secretary Mutahi Kagwe (pictured), in a statement released yesterday, said 1,016 cases had been detected from some 6,151 samples conducted in the last 24. Total confirmed cases are now 115,031.

Out of the confirmed cases 964 are Kenyans while 100 are foreigners. 55 were males and 596 females. The youngest is a two-year old baby while the oldest is 91.

Notably, seven more patients succumbed pushing the number of deaths to 1,925.

"Our sincere condolences to families and friends who have lost their loved ones," he said.

The statement said Nairobi leads with 681 new cases followed by Kiambu (93), Nakuru (69), Uasin Gishu (40), Kisumu (25), Kajiado (23), Busia (20) and Machakos 17 among others. A total of 709 patients are currently admitted in various health facilities countrywide while 2,223 are under the home based isolation and care programme.

The number of patients in the Intensive Care Units stands at 104, Kagwe stated.

On a positive note, 185 patients have been discharged after recovering while 149 are under home-based care.



Sh2,000 fine or one-month jail term for failure to wear mask

Kisumu County Covid-19 multi-agency Committee has instituted new stringent measures against Covid-19.

Among the new rules announced yesterday include a Sh2,000 fine or one-month imprisonment for those who fail to wear masks in public.

The committee also announced that other stiff measures will be instituted against Covid-19 patients in isolation centres who violate laid down guidelines. Further, it directed all morgues

not to preserve dead bodies for a period exceeding 72 hours and not to release any body after 10am.

New regulations also banned catering services in funerals and restricted such ceremonies to 100 people.

The team reiterated that bars and restaurants that do not adhere to the Covid-19 prescribed regulations shall have their operation licenses revoked.

Governor Anyang' Nyong'o said the new measures are expected to take effect immediately in a bid to control a rising third wave of Covid in the county.

Senior county advisor dies of Covid-19

A deputy director in charge of political affairs at the Nakuru County Government has succumbed to coronavirus after battling the disease for more than three weeks in hospital.

Breaking the news yesterday, Governor Lee Kinyanjui said Wilfred Chebochok (pictured) died while receiving treatment.

by the day-to-day data provided by the Health Executive Kariuki Gichuki in the last few days. For instance, on March 13, the county reported 119 new cases from some 398 samples tested, which translates to 30 per cent positivity rate, accounting to 13 per cent of the national caseload on that particular day alone. Cumulatively, Nakuru has confirmed a total of 5,103 cases accounting to 4.6 per cent of the cases reported nationally since the start of the pandemic. Overall, the positivity rate in the county is 9.4 per cent, said Gichuki.



Firm fires two revenue workers over theft of Sh6 million

Kitui Water and Sanitation Company (Kitwasco) has dismissed two revenue officers accused of siphoning Sh6.3 million in fictitious water bills.

David Musyoka and Esther Syombua allegedly altered customer bills in the company billing system they were managing, thus denying the company revenue.

According to a report tabled before Kitui County Assembly's Labour and

Social Welfare Committee on Monday, Kitwasco boss Geoffrey Kiita (pictured) said an audit report carried out between July 2016 to December 2017 revealed the fraud orchestrated by the two revenue officers.

Kiita said the alterations were made during the transition period from analogue to digital platform. "The officers, who were the sole administrators of the billing system, would credit

customer bills but revenue collected was not reflected in the bank," he said.

Death threats

Kiita disclosed that the Company's board decided to conduct a forensic audit of the revenue collections to ascertain any financial impropriety.

"Following a successful audit, the two revenue officers were found

culpable for the loss of Sh 6, 294, 094. These monies were unaccounted for. The duo was unable to conceal the money trail that indicted them of malpractice," revealed the MD.

However, the MD told the committee that his life is in danger after receiving death threats from Syombua's husband John Mwalwa Mutua after her acrimonious exit from the company. **-KNA**

Drama as Khaminwa walks out of court in Sonko case

Veteran lawyer accuses Chief Magistrate Ogoti of bias and not being furnished with proper documents on the case

Veteran lawyer John Khaminwa yesterday withdrew from former Nairobi Governor Mike Sonko's Sh10 million corruption case accusing the trial magistrate of being biased.

Khaminwa told the media outside Milimani Law Courts that he took the decision after Chief Magistrate Douglas Ogoti declined his application to adjourn the matter to allow him get proper instructions from Sonko before the matter could proceed.

The lawyer, who walked out of the court proceedings cited bias on the part of the magistrate and not being furnished with proper documents as the reason for his move to leave the court session, while also questioning the decision by the court to exclude media from covering proceedings of the case.

"I have left the court room. I do not think it will be fair for me to be party to proceedings where I don't even have proper instructions from the former governor, and as such, I will not be of help to the former governor," said Khaminwa.

He stated the trial against Sonko is unconstitutional as the magistrate has declined to allow the defence more time to prepare.

Khaminwa accused the magistrate of denying Sonko a fair trial by extending the proceedings up to night and also allowing protected witnesses to testify.

He wondered why the magistrate had barred the media from covering the matter yesterday, given that it is a public hearing.

The amount of money Governor Sonko is alleged to have received from Web Tribe to facilitate payments by the county government.

"Under Article 50 of the Constitution, the media represents the public and there is no way you can shut it out," said the lawyer.

However, the High Court early last year allowed the prosecution witnesses to testify behind closed doors. So far, 10 protected witnesses have testified in the case.

Further, he claimed that one of the lawyers representing Sonko in the graft case had tested positive for the coronavirus and Sonko had lost his driver in an accident thereby the court would have allowed an adjournment.

Khaminwa was hired by Sonko to replace his previous legal team that was led by lawyer Cecil Miller and George Kithi who abandoned the case following disagreements with the court in December 2020.

Now only Assa Nyakundi and Wilfred Nyamu will continue representing Sonko

in the corruption case. On March 15, 2021, Ogoti ordered Sonko appear in court in person for the hearing of his case after he skipped court on Monday.

This is after the court on March 4, 2021 directed that Sonko's case has to proceed for further hearing without further delay with or without his lawyers.

"The accused must take charge of his case. He should ensure he has all the disclosed court documents in his possession. Any advocate accepting this case that is an ongoing matter in court should first appraise himself regarding trial before accepting the brief," Ogoti ruled.

He said no advocate or accused would be heard on adjournment for lack of sufficient instructions.

On Monday, Ogoti issued orders to have Sonko appear in court in person for the hearing of his case after he skipped court.

Karoney while condoling with the family, in a statement said she was saddened by the demise of Njogu.

Legacy and contribution

"I worked with Robin for many years managing radio news and this is a huge loss to the Royal Media Services family and the media fraternity. May God be gracious with his soul," said Karoney.

On his part, Mutua said that he was heartbroken to lose a friend and fellow journalist.

"The other day when I visited him at the hospital, he was cheerful and getting better. He sent me this photo recently of the days when he used to attend my Govt. Spokesperson briefings as reporter," said Mutua.

Royal Media Services (RMS) Managing Director Wachira Waruru said Njogu's death is a big loss not only to the organisation but also to the entire media fraternity in Kenya.

Waruru said his legacy and contribution to the media industry, and radio journalism, in particular, will continue to impact many generations after him.

"I received the news of Robin's passing with shock and disbelief. Robin was a

talented journalist and editor whose firm leadership ensured high-quality editorial products across all the RMS radio stations. Known for his gentle demeanor, Robin excelled at developing and keeping great talent within the stations and was always a step ahead of the competition," he said.

Waruru said Njogu exhibited a great understanding of the local news environment and the events that shape it.

This development comes even as media players called for the need to have journalists listed as frontline workers and considered for the coronavirus vaccination after the demise of Njogu, who lost the battle to the virus on Monday night.

Kenya Union of Journalists Secretary General Erick Oduor while acknowledging that Njogu had contracted the virus, he appealed to the government to consider incorporating journalists in the inoculation drive.

Journalist's death raises questions on exposure

The death of veteran journalist Robin Njogu now raises concerns over how exposed journalists are to Covid-19 disease in their line of duty.

Kenya Union of Journalists (KUJ) said yesterday that at least 20 journalists are currently battling Covid-19 in various medical facilities.

KUJ Secretary General, Erick Oduor yesterday renewed an earlier petition to Government that journalists be considered among the frontline workers to receive the AstraZeneca vaccine.

"In view of the loss of life and reports of over 20 journalists battling the virus in medical facilities across the country, we believe that considering journalists to be among the first beneficiaries of the vaccine that is expected to land in the country anytime," said Oduor in a statement.

Immediate action

He said that journalists have suffered in silence, even as he urged those affected to speak up for immediate action or support before it is too late.

"It should be noted that in the efforts to control the spread of the virus journalists have been at the forefront in assisting government with identification of potential hotspots as well as carrying out campaigns to turn the tide against the virus. As journalists continue with this important endeavor, it is only fair that the government makes available all the possible facilities and protection to them," he added.

He stated that it beats logic to classify journalists as frontline workers only when their services are needed to contribute to the national campaign in informing and educating the public and then abandon them.

"This gives credence to the fact that journalists are only important when their selfless services are needed at the time of crises but are on their own when it comes to the protection of their rights and welfare," regretted Oduor.

He described it as imprudent and discriminative to expect journalists to play a delicate role in the Covid-19 battle, by exposing themselves to the virus while reporting new developments on the pandemic, including messaging on the fast-changing containment measures to the public, without targeted efforts to secure their own safety.



Court annuls Tana River BBI adoption after petition

The High Court in Malindi has nullified the decision by Tana River County Assembly, to adopt the constitutional amendment bill 2021, citing lack of public participation.

Malindi resident judge Reuben Nyakundi (pictured) in his ruling said that the draft bill failed to give sufficient notice to the public and indiscriminately enforcement of it by the County Assembly mistakenly was a misrepresentation and a violation of the Constitution.

"A declaration is hereby issued, declaring Tana River County Assembly resolution to adopt the constitutional amendment draft bill 2021, to be tainted with procedural illegality and due process and for being fatally defective and

unconstitutional," he said.

"The declaration, listing of Tana River County by the Speaker of the National Assembly as a bona fide legislative assembly resolution validly debated, adopted and obtained thereto in compliance with the cannons of the constitution is hereby rescinded and recalled for being void ab initio (of no legal effect)," ruled the judge.

Orders to Speaker

Justice Nyakundi further issued orders to the Speaker of the National Assembly, Speaker of the Senate to move and delete the name of Tana River County Assembly adoption of the draft bill.

"For failure to fulfill the basic tenets embodied in the set of prin-



ciples contained under Article 10 of the Constitution on public participation and inclusivity I immediately direct the above to remove the name of Tana River County as among counties which passed the bill," he said.

Adding that statutes with a constitutional foundation must be drawn, debated, understood and passed by the Kenya people to operate as a balance between the state and the governed.

"There can be no rational governance for a man to be governed by a constitution that was kept secret from him in complete violation of the rules of natural justice. That arbitrary and haste action by the speaker of the County Assembly to close the debate on the draft bill in microwave time before receipt of any written memorandum or engaging the public to gather views was an act in violation of Article 1, 2, 10, 27, 33, 73, 174 (c), 184, 196, 201, 259 and fourth schedule of the Constitution," he said.

Protect journalists from coronavirus

The work journalists do cannot be gainsaid. They risk life and limb to keep society informed. They keep governments and institutions in check and are the voice of the voiceless in their day-to-day activities. Journalists have changed lives, rubbed many shoulders the wrong way and stood as the last pillar of good governance when all other institutions have crumbled.

Simply put, journalism is sacrosanct. Yesterday, a senior editor with Royal Media Services succumbed to suspected Covid-19.

Robin Njogu plied his trade as a radio editor and his contribution to broadcasting has been immense. As news of Njogu's death trickled in, a newspaper correspondent in Nairobi developed breathing difficulties associated with coronavirus. With no insurance to his name and no savings (he relies on his story contributions to earn), he was staring at death. His only saving grace was that he is a member of the Kenya Union of Journalists and the officials came to his aid, rushing him to a city hospital for Covid-19 medication. After treatment, his only hope of getting discharged would be a fundraiser.

Tributes for Njogu rolled in from the high and mighty: From President Uhuru Kenyatta and his deputy William Ruto to Cabinet Secretaries, politicians and professional colleagues. This level of interaction was only made possible through the work he did. Journalists report on politicians and as witnessed lately expose themselves to all manner of risk, including Covid-19 through gatherings and interactions. They cannot abscond duty because the profession is a calling. For this reason, we are asking the government through the Ministry of Health to prioritise vaccinating journalists as frontline workers. India has acknowledged this class and so has Zimbabwe, do not leave this important cadre to their elements.

Media owners and employers should also up their game in protecting journalists. Provision of protective equipment should be given priority and those not equipped should not be deployed on the frontline. Insurance for journalists should not be an afterthought. The correspondent's condition may have deteriorated by the urge to work even when his health was at risk, so as to feed his family. Proper remuneration, restoration of full pay and salary cushion for journalists is a right. Indeed, of what use is a scoop or award winning story when the writer, broadcaster or photographer leaves behind a family that has no means of survival because they risked life to tell a story?



Meaningful steps needed to actualise gender equality

The essential role women play in all spheres of society is globally being recognised this month of March. This year's commemoration comes at a critical moment when Covid-19 pandemic has further exposed the vulnerabilities women and girls face.

Women struggle now more than ever before to sustain an equal footing in the economy. Their pandemic experience is shaped by increasing domestic and workplace violence, enhanced care responsibilities and disproportionate lack of access to working capital. More broadly, power is unequally distributed while the gender pay gap persists in most countries. Yet, providing women and girls with equal access to education, participation in political and economic decision-making processes has widespread benefits to society. Governments can play their part, but without the partnership of the private sector, this goal will not be easily attained.

Inaction on gender disparity, as with all the other Sustainable Development Goals (SDGs) is much more costly than action. Achieving 30 per cent female representation on corporate boards could add six percentage points to net margin, and research shows that companies in the top quartile for gender diversity on their executive teams are 21 per cent more likely to experience above-average profitability than companies in the fourth quartile.

To make gender equality everyone's business, we need more men to step up and join efforts to drive this change. As holders of power, men can be allies in driving meaningful

progress by setting the right tone and developing holistic strategies with time-bound, measurable goals and targets.

Evidence also shows that realising gender equality and women's rights, holds the greatest potential to eliminate poverty and hunger, achieve quality education for everyone and achieve all the SDGs by 2030. To make headway in "building back better" in a post-pandemic setting, policymakers at all levels must respond to the unique challenges women face to ensure they are not left further behind.

According to the United Nations Global Compact Target Gender Equality Covid-19 Quiz, 89 per cent of surveyed companies indicated that women are actively informing company Covid-19 response and are included at the decision-making table. Boards that value diversity and inclusion will be better placed at responding effectively to emerging challenges that affect different groups. Boards with at least 30 per cent female representation provide a favourable environment for innovative ideas emerging from gender diversity.

The first two principles of the UN Global

Compact Principles are integral to respect for human rights. These principles call for safeguarding of women's rights. All businesses, have a responsibility to ensure, women are not subjected to discrimination, sexual harassment, or backlash at workplace. It is not too late for businesses to take meaningful steps to promote equality and diversity. Companies can demonstrate their commitment to getting more women in leadership by signing the Women Empowerment Principles, signalling their commitment to advance gender equality.

Unpaid care work has been a major impediment to women's equal participation in the labour force. Women already do three times the amount of unpaid care work as men. To ensure that every employee feels supported and valued especially during the pandemic, businesses should invest in family-friendly policies such as parental leave, supporting childcare and flexible work schedules.

The future looks brighter when women are at the helm of every table where decisions are being made. As we unite in solidarity to support the recovery of societies that are resilient, inclusive and gender-inclusive, we must ensure that women and girls are at the centre of decision making. In the decade of action, we need businesses to be intentional and ambitious for the realisation of the economic value gender equality brings.

Bravo SGR for positive change in transport sector

The history of transport is largely one of technological innovation. Advances in technology have allowed people to travel farther, explore more territory, and expand their influence over larger areas.

Even in ancient times, new tools such as foot coverings and snowshoes, lengthened the distances that could be traveled. As new inventions and discoveries were applied to transport problems, travel time decreased while the ability to move larger loads increased.

International trade was the driving motivator behind advancements in global transportation in the pre-modern world. There was a single global world economy with a worldwide division of labour and multilateral trade from 1,500 onward. To increase efficiency, transport services were integrated as evidenced by the establishment of the East African Railways and Harbours Corporation, a defunct company that operated railways and harbours in East Africa from 1948 to 1977.

It was formed in 1948 for the new East African High Commission by merging the Kenya and Uganda railways and harbours with the Tanganyika Railway. As well as running railways and harbours in the three territories, it ran inland shipping ser-

vices on Lake Victoria, Lake Kyoga, Lake Albert, the Victoria Nile and the Albert Nile. But now, the Standard Gauge Railway (SGR), the flagship project of the Belt and Road Initiative (BRI), remains significant in terms of saving valued natural resources and protecting the environment, especially from the challenge of global warming. Its operations have continued to play positive effects on delivery of both passengers and cargo.

From passenger trains inaugurated by President Uhuru Kenyatta on June 1, 2017 that initially had one train per each direction, the service has improved to current state of three trains both directions. During the period of June 2017 up to end February 2021, 4,356 passenger trains have moved both directions delivering 5,200,000 passengers, a service that has proved popular with on time schedule train arrivals. On the Freight cargo service that commenced on January 1, 2018, SGR has maintained a steady off-take of cargo from the port that has seen 7,280

trains moved delivering 726,485 TEUs.

The SGR has also had a multiplier effect on the economy by spurring the growth of the tourism sector at the coast. At least 65 per cent of all the tourists arriving in Nairobi from abroad and the national parks ride the Madaraka Express to Mombasa. The cost of production and manufacturing has been lowered, and agriculture and service industry has experienced exponential growth. Import tonnage moved 12,414,615 tons. Export and empty containers delivered via SGR stand at 439,565 TEUs, contributing to 1,509,778 tons. This has positively enhanced cargo throughput from the port by rail, reducing dwell time and quick turnaround on vessels at the port. The improved service has seen a daily wagon supply for containerised cargo oscillating between 400 to 450 per 24 hours. With the recently introduced new service on double deck wagons on containers, two such trains are currently active, delivering

152 TEUs per move.

To further enhance service improvement, conventional bulk loading using both high open wagons and special containers has been ongoing, enabling daily delivery of 7000 metric tons per day of wheat to Nairobi for both local and transit clients. With the recent operational coordination merger of KR, KPA and KRA with joint approach on port operations, both organisations are currently working together to provide seamless cargo evacuations needs.

As the government continues to mitigate the effects of the Covid-19 pandemic, the SGR operator ensures strict adherence to the laid down protocols.

Given the resilience of and key milestones achieved by the SGR within the last three years, it remains the preferred mode of transport. The milestones include the launch of the Nairobi-Mombasa passenger train in June 2017, the launch of the inter-county passenger service in November 2017, the inauguration of Phase 2A passenger service by President Kenyatta in October 2019 and the celebration of safely operating the Madaraka Express service for 1000 days.

A misguided campaign pitch by a candidate for the Machakos Senatorial seat, caused consternation in the county on Monday night after the PR team released a statement to the radio station. The message intended for publication was way past the campaign deadline, forcing local electoral body officials to react, adding more confusion to the matter at hand. Perhaps, what looked like an innocent mistake might have worked for the PR guru handling the communication for the candidate.

Flamboyant trader in hot soup over sour deal

A leading businessman in the country is in hot soup after his companies were mentioned in several government tender scams. The trader of Somali origin is at the centre of a scam in which his firm is being accused of repackaging relief food after delivery at the government go-downs at the Industrial Area, Nairobi. Street Talk has learnt that the monied gentleman has had several meetings with the multi-agency team and an even longer session with the taxman. Speculation is rife that he is protected.

Reality check on future of learning post Covid

Education is one of the key pillars of development in any country. The main motive of education is to impart knowledge to all learners in a well-defined curriculum.

However, with the emergence of Covid-19, education and learning seems to have been highly differentiated and it is important to understand the meaning of the two and look at the future of both.

Jeff Cobb, a renowned author of the book *Philosophically Speaking* defines learning as "the lifelong process of transforming information and experience into knowledge, skills, behaviors, and attitudes".

According to him, education is just a small component of learning. In this sense, education and learning are related.

However, learning is much broader and does not necessarily dwell on acquisition of knowledge and skills, but emphasises on lifelong transformation. This clearly denotes that learning starts way before we enter education institutions.

In the pre-Covid period, learning and education seemed to have

been equal because learning was synonymous with being physically in school. Online learning was a rare item, especially for secondary and primary school children. In fact, it was almost inconceivable to imagine that learning would happen at home. Following the spread of the pandemic, schools adopted online learning through Zoom, Microsoft Teams and Google Classroom. Many online learning systems started to emerge with some stand-alone learning platforms while others came in as complete Learning Management Systems (LMS), incorporating distance-learning modules. Of all the systems sampled in the market, LMS offer a very comprehensive approach; similar to web-based platforms for the same category of users.

Covid-19 has formalised home-schooling for basic education. A

keen look at the curriculum that was proposed for Community Based Learning, shows that the crisis has ushered in a complete transformation in the education sector. Some of the areas of emphasis are entrepreneurship, financial management, innovations, design thinking, coding and programming, whose intention was to create self-reliant individuals from our learning undertakings. Through the LMS, pupils have also expanded their learning skills.

The big question remains, "what is the future of learning in Kenya post Covid-19?"

Teachers should be more innovative in delivering content to supplement physical learning. Additionally, the government ought to play a bigger role in policy-making and quality control and leave the management of schools to private entrepreneurs

to enhance growth and quality. Examination bodies will also need to find new ways of assessment. Exams will change in terms of both the nature, content and management. This will eventually digitise the learner's portfolio and keep a long-term stage-by-stage performance record of the learners. There should also be a consideration of digital libraries.

As part of making learning truly transformative, some old learning areas will start to fade. Key areas to watch will be financial management for youth, entrepreneurship, innovation and design thinking, coding, photography and videography.

Enhanced parent-teacher school engagements should replace a diary that only communicates after the pupils reach their homes.

In conclusion, learning will change drastically. This is not just in learning institutions but the same dynamics that apply across various sectors, business lines and even the social or nonprofit-based institutions.

Sossion accuses TSC of attempts to muzzle Knut

Unionist claims teachers' employer has manipulated their register to paint picture of moribund union

Kenya National Union of Teachers (Knut) yesterday expressed frustrations over what it termed as persistent, unfair, prejudicial and discriminatory treatment by the Teachers Service Commission (TSC)...

In a press statement, Knut Secretary-General Wilson Sossion said the union has conducted its branch elections despite the spirited and systematic propaganda by TSC aimed at building a false image of the union.

He regretted that the commission has manipulated the union's register to shape perception that Knut membership has diminished from 187,471 to 17,000.

True position

"The true position of Knut membership status is that union membership register is intact contrary to TSC distorting reality thus generating fear, panic and anxiety among members that their only union – the union of choice is on the verge of collapse," said Sossion.

To influence teachers' action by manipulating Knut register to read wrong figures of teachers affiliated to the union, Sossion said TSC has issued inflammatory statements aimed at throwing tutors and their leadership off guard.

He also accused TSC of peddling lies, misinformation and inflammatory language to achieve an objective of the commission, which is to instill fear, anger and doubt in Knut so that members can lose trust, confidence and faith in the union and its leadership. "The commission has

In a well choreographed scheme to drive Knut members out of the union, TSC has been dangling promotions and salaries with 'strings attached' – that you ship out of Knut and get promoted with a salary rise or stick with the union and miss it all," Sossion uttered.

He stated that TSC has in some cases, literally denied deserving teachers promotions until and unless they quit Knut, adding that attempts by the commission to strip heads of schools and other administrative staff of union rights will be resisted by Knut.

Sossion added that the union is persuaded to believe that all the deliberate and systematic attempts by TSC to shape perceptions and manipulate cognitions of Knut members to achieve a response that furthers its desired intents.

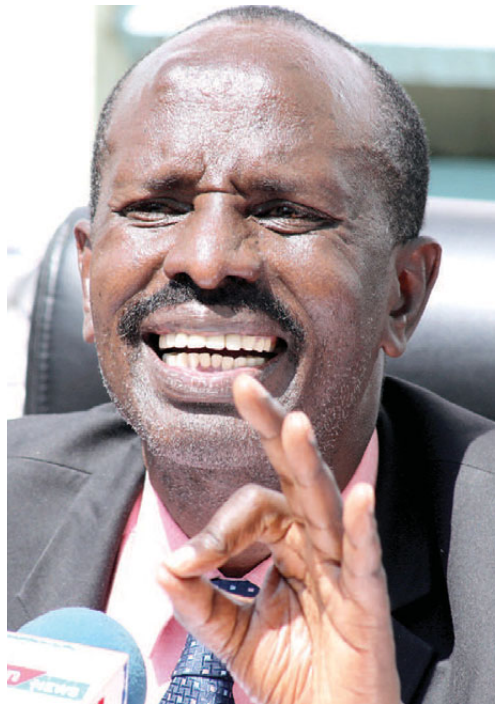
He explained that one of the reasons Knut is at crossroads with TSC is because of attempts by the Employment and Labour Relations Court and Ministry of Labour to create sanity has failed due to commission's attitude of ignorance, ineptness, impunity and gross violations of the Constitution.

Career Progression Guidelines (CPG) has also been a bone of contention between TSC and Knut, with the latter saying it is opposed to them because they abuse labour and professional rights of teachers.

According to Sossion, under CPG, teachers who attain higher qualifications have been denied automatic promotion unless they have been assigned administrative positions.

He reiterated that the schemes of service that were replaced by CPG gave a leeway to teachers who attained higher qualifications to automatically ascend to higher grades.

"From Job Group M and above, it was competitive promotion that inspired

teachers to perfect their performance as professionals, CPG have since rubbished this mode of promoting teachers of which Knut is opposed to," Sossion insisted.

Sossion further maintained that despite funding shortage owing to TSC's actions, only two branches out of 110 didn't, which would be held after Covid-19 restrictions are relaxed to pave way for national elections.

Delegates conference

Knut national elections will be held during an Annual Delegates Conference at a date to be communicated later.

"It has only been possible to organise and hold elections through financial support from Education International and logistics from International Labour Organisation, National Education Union in Britain, US National Education Association and Ghana National Association of Teachers among others," Sossion stated.

The Secretary General observed that it would be a bad legacy for Government if it fails to address the stalemate between Knut and TSC, saying move will undermine delivery of quality education.

Cleric urges peace ahead of referendum

National Council of Churches of Kenya (NCCCK) yesterday urged Kenyans to promote peace in an effort to forestall violence amid rising political intolerance in the country.

South Rift chairman Rev Ernest Ng'eno noted that it was unfortunate that the nation was slowly sliding into barbarity after pockets of violence erupted during mini polls.

He said it was high time for concerted efforts to be applied to avert any action that may threaten peace, saying referendum push must not be the cause for division.

"Allow other people to hold and express their opinions whether you support or oppose the referendum push. We are a democratic nation, and we need peace," said Rev Ng'eno.

Speaking in Nakuru after meeting the regional committee members of the NCCCK, Ng'eno said security forces also needed to promote peace before, during and after the referendum.

According to him, no life should be lost and property destroyed due to conflicting views concerning the constitutional amendment calling on leaders to lead by example.

"Any person who incites violence regardless of their status in society should have action taken against them," added Ng'eno.

The cleric noted that residents in Rift Valley are tired of violence and economic instability at every election, saying the region has been volatile and prone to violence after every five years.

"We need to put an end to divisive politics and the cycle of election-related violence. Reject any political actor who spews hate," said Ng'eno.

Ng'eno further added that the country must be adequately prepared to conduct next year's General Elections through the appointing a fully functioning electoral body.

Residents up in arms over water shortage

They accused the regional Nzowasco manager of giving them empty promises and demanded investigation into the crisis.

"For more than two months now we have been buying



water for both commercial and domestic use despite the heavy billing by Nzowasco. The management must come up with a long-lasting solution," he said.

The residents now allege foul play between some Nzowasco staff and private water that has occasioned the crisis.

Peter Simiyu, an hotelier,

said a majority of residents were paying standing water charges despite the scarcity and asked the water service provider to investigate those concerned.

Water and Environment Executive Andrew Musungu, however, said he was liaising with Nzowasco to address the issue.

He warned that anyone found diverting water face the law. "The county government is committed to providing a long lasting solution to concerns raised by consumers of water.

The matter of some Nzowasco staff colluding with cartels will be investigated and those found culpable will be prosecuted," he said.

Curtails supply

Nzowasco director Lusweti Furaha denied allegations that some employees were colluding with cartels to curtail water supply.

Some of the areas affected include Milimani, St Joseph's, Tuwani, Kipsongok, Shimo la Tewa, Tuwani, Matisi, Mitume and Gatua.

Kabarnet woman arraigned after assaulting ailing granny

A middle-aged woman was arraigned at a Kabarnet court on Monday for assaulting her hospitalised grandmother.

Emily Jeposkwony was charged with assault and causing bodily harm contrary to section 251 of the Penal Code.

The charge-sheet filed in court stated that on March 5 at about 4:30pm at Tenges Health Centre in Baringo Central sub-county within Baringo County, Jeposkwony unlawfully assaulted Shokwei Cheruiyot, who is nursing bruises, occasioning her actual bodily harm.

Appearing before Senior

Principal Magistrate Paul Biwott, the accused denied the charges. "It is not true, I was trying to help her by cutting the nails and accidentally pricked the wounds," said Jeposkwony.

Prosecution Counsel Joseph Abwajo prayed for more time, because the treatment note had not yet been brought to the court.

Magistrate did not oppose the submission but ordered the accused to be released on Sh50,000 bond with one surety of similar amount or a cash bail of Sh10,000.

Case will be heard on April 12.

Nema warns on sale of plastic bags

National Environmental Management Authority (Nema) yesterday warned Busia residents against sale and use of plastic bags.

County Nema director Kipkoech Rop blamed increased use of the banned products on the porous Kenya-Uganda border.

"Seemingly, Busia residents have forgotten the ban on sugar bags is still in force, it is illegal to use the bags so let those still using them stop," Rop added.

The official said they are working with relevant authorities to ensure culprits are apprehended.

"The law is very clear for anyone found using the banned plastic bags, if you are found with plastic bags, you will be fined up to Sh1 million or four years in jail," said Rop.

Climate change

Area County Government Director of Environment and Natural Resources Dennis Chirande noted environmental degradation is on the increase, saying there is need to involve all stakeholders to address the problem.

"It is time the county adopts a strategy that is essential in terms of addressing environmental degradation, awareness, funding levels and other emerging issues such as climate change," he said.

The ban on all plastic carrier bags and flat bags used for commercial and household packaging in Kenya took effect on August 28, 2017.

Sabatia lawmaker caught up in Sh640 million tender row

Bidder has moved to court seeking to nullify technology tender for servicing of IFMIS citing fraud in the process

A new row has emerged at the National Treasury following the award of a Sh647 million tender to a firm associated with Sabatia MP Alfred Agoi.

The revelation comes after a bidder moved to the High Court seeking to nullify the technology tender for servicing the Integrated Financial Management System (IFMIS).

The High Court has since temporarily suspended the award to a consortium led by Kingsway Business Systems following a case filed by a rival firm, ADK Technologies citing fraud in the tendering process.

ADK argues that its rival did not meet the technical specification for the IT deal claiming the firm was specialised in insurance services and not ICT products.

According to records at Treasury, Kingsway Business Systems Limited listed directors include Simeon Ogendo, Seth Asua Changilwa, Alfred Agoi Masadia and Beatrice Kosgei. ADK through lawyer Duncan Kiprono wants the High Court to compel the Public Procurement Administrative Review Board (PPARB) to review the case afresh after the tribunal dismissed it last month.

He has listed PPARB as respondent while

the PS National Treasury and Kingsway Business Solutions are listed as interested parties. Treasury had invited eligible bidders to bid for Tender No. TNT/049/2019-2020 for Provision of Onsite Support for IFMIS Applications, Enhancement of IFMIS E-Procurement and Independent Integrated Financial Management Information System for Semi-Autonomous Government Agency (SAGA) through an advertisement published on June 16, 2020.

Five bidders applied for the tender by close of deadline; M/s Sybil Kenya Limited, M/s Kingsway Business Systems Limited in Consortium with M/s Kobby, Technologies Ltd and M/s Implenion Eastern Africa Limited, M/s Next Technologies, M/s Ubora Systems and Solutions in consortium with M/s Tech Mahindra and M/s Transnational Computer Technology in consortium with ADK - Technologies

Kingsway led consortium was the least evaluated at Sh647, 064,000.00, Next Technologies Sh651, 102,609.48 and ADK led consortium Sh898, 948,256.00

On January 25, 2021, Treasury PS Julius Muia notified bidders that a consortium headed by Kingsway Business Systems Limited were successful for the deal.

However M/SADK Technologies Limited lodged a request for review on February 8, 2021 at the Public Procurement Administrative Review Board (PPARB) citing fraud.

The Faith Waigwa-led board dismissed the request for review on grounds that the application was not properly filed before the Board as there was no evidence provided of authorisation for one Samuel Haile

Nigussie to appeal the decision.

Dissatisfied, ADK Technologies moved to the High Court seeking a judicial review of the PPARB decision and also stop Treasury from signing the contract until the case is heard and determined. On March 6, 2021, Justice Jaurus Ngaah issued an order temporarily stopping the Treasury from awarding the contract.

According to suit papers, ADK claims that Kingsway Business Systems Limited has been providing to the National Treasury for the last 10 years Group Personal Accident services but not IT services.

ADK claims that in March 2020, Kingsway purchased an entry level partnership from Oracle in what appears to be credential acquisitions in preparation for the tender.

ADK's Project Manager Nigussie says: "I verily believe that procuring entity might have engaged in a flawed procurement process and acted against the laid down laws and procedures, to tilt the scales to enable them carry out a sham procurement process and act in breach of the provisions of law in order to favor Kingsway business solutions."

Police hunt for three suspected loggers over killing of warden

A Kenya Wildlife Service game warden in Kakamega Forest in Shinyalu constituency was allegedly killed by an illegal logger on Monday evening.

Raymond Suter, who is stationed at Iloro Kenya Forest Service Camp, died on the spot after he was hacked by a logger he was pursuing.

Shinyalu police commander Robert Makau said the deceased was in the company of two fellow wardens on patrol at Mang'ang'a area in the rainforest when they bumped into two loggers who were illegally felling pine trees.

The other wardens were Alexander Muyukumba and Japheth Mutai.

"The trio came across two men cutting a pine tree near a herd of cattle that were grazing in the forest. On spotting them, the men started running in different directions," the police boss said.

He said Suter ran after one of the loggers while Mutai pursued the other one. Muyukumba was left guarding the herd of cattle.

"After a few minutes, Mutai gave up the chase as the sus-

pect was too fast for him and went back to where Muyukumba was," he said.

The police boss said the duo waited for their colleague for more than 30 minutes but he did not show up.

"They started looking for him on the route he had pursued the fleeing suspect. They found him lying on the ground dead bleeding from a deep cut on the back of his head and another one above the right ear while clutching on to the AK 47 rifle

together with a magazine containing 29 rounds of ammunition," he narrated.

He said all the suspects vanished into the thick forest adding that no arrests had been made by yesterday.

The deceased's body was taken to Kakamega County Referral Hospital mortuary.

Meanwhile, the animals were rounded up but their owners had not yet showed up to claim them by the time of going to the press.

Shift in cash crops as macadamia farming takes root in Nakuru County

For countless years, maize and potatoes farming has been a major source of income for thousands of farmers in Nakuru County.

However, macadamia is the cash crop of the moment for many farmers in Solai village within Rongai Sub-County.

The revival of the crop is coming at a time when fortunes of Kenya's traditional cash crops namely coffee and tea are dwindling.

Riding on renewed interest in the macadamia nuts venture the County Government has set aside Sh5 million for purchase of planting material with Governor Lee Kinyanjui announcing that the devolved unit's department of agriculture had already distributed 14,000 macadamia seedlings to help farmers diver-

sify their incomes.

Speaking after touring 13 macadamia farms in the sub-county, Kinyanjui noted that macadamia farming was a lucrative business and directed agricultural officers to enhance extension services.

"A farmer can harvest up to three tonnes of macadamia nuts per acre with a production cost lower than that of cash crops like tea and coffee.

Technical assistance

We will provide farmers with technical assistance and inputs to see that they get good income by integrating macadamia and other crops," said the governor.

He was accompanied by his wife Elizabeth Kinyanjui, Deputy



Governor Dr Eric Korir and County Executive Committee Member for Agriculture, Livestock and Fisheries Dr. Immaculate Maina.

The governor noted that a macadamia tree can yield an average of 70 kilos of nuts per season, with a kilo selling for Sh200.

Free seedlings

The county government estimates Nakuru's nut production potential at over 20,000 metric tonnes, which it aims to achieve by distributing the free seedlings. A macadamia tree takes around four years to mature.

Kinyanjui observed that Macadamia was highly tolerant against harsh weather, pests and diseases making it a better option for farm-

ers in Kenya amid the uncontrolled effects of climate change. He stated that a macadamia tree had a long lifespan unless affected by a disease like powdery mildew at flowering stage which causes deflowering and poor quality of little nuts produced. Macadamia nuts can be eaten raw or processed into cooking fat.

Kenya is the third top producer of macadamia in the world after South Africa and Australia.

According to Agriculture and Food Authority (AFA) Kenya's macadamia production has more than doubled in the past years as interest in the crop surges, from 11,000 tonnes in 2009 to over 50,000 currently. At least 30 firms process the nuts, which is before export.

Auditor faults NMS over Sh32 million withdrawal

Calls for EACC to investigate quasi-county body over likely loss of cash meant for war against Covid-19 pandemic

Auditor-General Nancy Gathungu has recommended that the Ethics and Anti-corruption Commission (EACC) investigate and takes action on officials of the Nairobi Metropolitan Services (NMS) over irregular withdrawal and possible loss of Sh32.38 million meant to fight Covid-19 pandemic.

The Auditor also questioned the whereabouts of Sh180.07 million raised to aid in the fight against the virus as she flagged irregular direct procurement by the agency.

NMS, the entity that took over key function of city hall, including Health, irregularly withdrew Sh32.38 million from KCB-impresits account reportedly for facilitation of health workers on Covid-19 rapid response activities.

"The management could not explain the basis of the facilitation, authority to pay facilitation and expenditure could not be supported," the auditor's report reads in part.

The money was withdrawn at the height of the pandemic on June 30, 2020 allegedly for payment of facilitation of health workers on Covid-19 rapid response activities.

"Further investigations [should] be

conducted to establish any criminality," the auditor recommended in her report on the special audit on the utilization of Covid-19 funds.

The auditor could also not establish the whereabouts of some Sh182.07 million donated by Danish International Development Agency (Danida) and county's own generated revenue to boost the war against the infection.

"However, we could not establish where these funds were received and whether they were transferred to the respective health centres. This is because the county management did not provide relevant documents," reads the report.

Citing Controller of Budget Margaret Nyakango's special report on Covid 19 funds released last year, Gathungu said that City Hall and NMS received Sh17.60 million as Danida funds and Sh164.47 million as own source contribution funds.

NMS funds

"The special audit could not establish whether DANIDA funds were received and utilized at the NMS or at the county government since neither of the two entities availed relevant documents," it says.

The report shows that NMS received a total of Sh294.38 million from the National government to fight the pandemic.

As at July 31, 2020, the NMS had incurred expenses of sh97.32 million which included procurement and payment of facilitation of health workers

The money excludes the county's own source revenue and Danida funds pumped

into the fight against the virus.

Carrefour Kenya defies pandemic to rake in Sh25.3b

Carrefour Supermarket made Sh25.3 billion (AED 848 million) in revenue last year compared to Sh19.4 billion (AED 651 million) in 2019. The performance was realised despite the local retail market and the economy as a whole being hit hard by the Covid-19 pandemic.

Revenue also grew despite a Sh1.4 billion drop in the retailer's total assets having decreased to Sh5.9 billion from Sh7.4 billion in 2019. "The ripple effect of the rapidly spreading pandemic has seen governments,

authorities and advisory councils around the world mandate appropriate drastic measures intended to control transmission," reads the Carrefour annual report in part.

"While this has seen some industries (particularly those in the tech and digital space) flourish overall, there has been a strongly adverse effect on discretionary spending and consumer confidence," it adds.

In Uganda, Carrefour yesterday opened its second store located in Naalya, Kampala signalling its desire to expand its footprint within the East African region.

Commenting on the launch,

Franck Moreau, Country Manager of Carrefour Uganda and at Majid Al Futtaim – Retail Kenya explained that Carrefour's underlying aim is to offer Ugandan shoppers the best products and widest range at the most affordable price.

Shopping experiences

With this expansion, he said the retail chain is delivering more convenient and modernised shopping experiences to more of our Ugandan customers. "This new Carrefour not only offers a wide range of products sold at the best prices, but also uplifts

the surrounding community by creating direct and indirect employment opportunities for over 90 Ugandans," he said. In the recent past, some key players in the local retail scene, such as Tuskys and Nakumatt supermarkets have sunk, an occurrence that has seen foreign-owned retailers such as Carrefour and Game increase their market share significantly. With Tuskys Supermarkets seemingly on its deathbed, the foreign brands are now having an easier time competing with Naivas, other home-grown brands and corner shops.

However, they are now facing stiffer competition from online retailers.

Delayed Ketraco projects to cost taxpayers dearly

Auditor General points at a contract signed in April 2013 to be completed by June 2019 but had to be stopped for non-performance

Auditor General has warned that re-scheduled multi-billion projects under the watch of Kenya Electricity Transmission Company (Ketraco) will cost taxpayers dearly after the contracted company went burst.

Mumbai-based Jyoti Structures Ltd has been put on the spot for a deal to design, deliver and commission lines and substations between 2013 and 2017 at an approved budget of Sh6.5 billion, with a government counter-funding of Sh3 billion.

The report by Auditor General Nancy Gathungu tabled in the National Assembly on February 18 notes that, the contract which was signed on April 16, 2013 was supposed to have been completed by June 30, 2019, but had to be terminated for non-performance. The project suffered a setback, when Jyoti's contract was terminated for non-performance, and insolvency, and the work has since been handed over to China CAMC Engineering Co. Limited.

Jyoti was to construct transmission lines between Bomet, Soti; Nanyuki to Nyahururu; Olkaria-Narok, and Lessos to Kabarnet at a cost of \$15.1 million (Sh547 million, exchange rate at the time) as well as Ishiara, to Kieni; Mwingi, Kitui, Wote and Sultan Hamud at a cost of \$10 million (Sh403 million).

Financed by the African Development (AfDB) and the Kenya Government through the Ministry of Energy and Petroleum and the National Treasury, the project involved construction of 431 km of 132KV lines, extension of six substations and construction of 8 new substations.

In the second instance, Gathungu said the same company was to deliver 132/33KV substations and 132KV line bay extensions at a combined cost of \$29.7 million (Sh3.7

Within schedule

"Consequently, the project may not be completed within schedule, resulting in delayed provision of expected services to the stakeholders," she added.

The report indicates that the project was beset with pending bills issues totalling

Sh727.73 million as at June 2020.

During the year under review, she said, the project management made payments totalling Sh74.8 million but accumulated bills worth Sh206 million. Gathungu warned the project was at risk of incurring significant interest costs and penalties with continued delay in payments.

In terms of budget control and performance, Gathungu said the statement of comparative budget and actual amounts of the year ended June 30, 2020, reflects actual receipts of Sh548.6 million against budgeted receipts of Sh462 million, resulting in an excess of Sh86,643,715.

Compensation to landowners for way-leaves acquired since inception of the project in April 16, 2013 amounted to Sh2.3 billion while amounts certified as payable amounted to Sh1.98 billion out of which Sh1.7 billion was paid, leaving an unpaid balance of Sh298 million.

"The management has attributed failure to pay the amount due to lack of budgetary allocation from the National Treasury and lengthy land valuation negotiations due to absentee land owners and various court injunctions on disputed cases," said Gathungu

New building code a game changer, says NCA official

The new building code, which is currently awaiting stakeholder validation, has been touted as a game changer for the building sector in Kenya.

Anchored in the National Construction Act via the Business Amendments (2020), the code (National Building Regulations) seeks to replace the current code which dates back to 1968. "The operationalisation of the draft Building Code 2020 in the built environment will achieve a healthier, safer, more convenient industry with optimal use of resources," said the Vice Chairman of the National Construction Authority (NCA), Zipporah Rotich. Rotich spoke yesterday during a building sector



stakeholders' forum held at a Nairobi hotel. She said the new code would enhance professionalism, streamline building approvals, reduce construction claims and increase the number of investors in the construction industry among other benefits. Rotich said the current Building Code, which dates back to 1968, is archaic. — Lewis Njoka

Farmers' agony as NCPB drains cash to buy maize

Board's chair says Sh1.2b that was allocated to buy maize from farmers has been exhausted

National Cereals and Produce Board (NCPB) has stopped buying maize from farmers as it has run out of cash it had allocated for the activity.

Chairman Mutea Iringo had earlier said the government gave the agency Sh1.6 billion two months ago, as part of the huge debts it is owed, to buy maize.

He said the cereals body allocated Sh1.2 billion from the money received to purchase maize from the farmers for commercial trading. The board buys maize under its commercial wing for trading alongside other grains like rice and beans.

"As at the end of last week, we had purchased 675,000 bags of 50kgs (375,000 bags of 90 kg bags) from farmers at Sh2,700 per bag, thus exhausting the set cash," Iringo said after touring NCPB depots in Nakuru town.

"We have to wait for further cash from budgetary allocation and payments owed mostly by government-related agencies," he added. The remaining of the cash of the Sh1.6 billion is being used for administration and other activities. The announcement by Iringo comes at a time when farmers had started queuing to various depots to sell their maize.

Various depots

He added: "The Sh1.2 billion was divided according to various depots across the country and many of them have now exhausted their allocation and are no longer buying maize." The poor financial base compounds farmers' challenges, especially those who do not have extra revenue source apart from maize.

The board's action prompts farmers now to source for market elsewhere until the government boost its coffers.

Chege Kiiru, a farmer in Nakuru County and who sells his maize to NCPB said there is a need for the organisation to rescind its decision and instead start buying the commodity on credit.

Iringo, however, said: "Under the new reforms the board is not expected to buy maize on credit. Unless otherwise the government stand is to buy and pay farmers

promptly. We will resume buying once our coffers are boosted." He said the cereal board is still grappling with high debts to the tune of Sh6.1 billion, money owed by various government agencies for services rendered, largely on grain handling.

"We are still pursuing the debts from the various government agencies and hoping that soon the debts will be cleared to enhance the financial base," he added. Iringo said the board is waiting for Sh4 billion to help it to continue purchasing more maize, beans, green grams, rice and fertiliser for the farmers.

NCPB, Iringo said, is expected to start buying more maize from the farmers to boost the National Food Reserve (NFR) once the national food balance sheet committee announces new prices.

The committee comprising various players including NCPB, Ministry of Agriculture and actors drawn from the private sector is expected to meet soon to discuss the status of the food situation in the country and advice on the various measures and interventions to be employed.

It provides information on the available food stock in the country and to inform the next step with regards to the national food reserve stock levels.

The NFR whose mandate is to manage and maintain the strategic food reserves

which offer a buffer stock for emergency purposes. Speaking to the Senate committee on Agriculture last week, Joseph Kimote, the managing director said NCPB will stop the purchase of maize from farmers once it exhausts Sh1.128 billion that was allocated by the government.

Financial limitations

He told the committee that as at March 4, the board had purchased 573,914 bags each weighing 50 kilogrammes at Sh860,511,780. "Upon exhaustion of these funds, NCPB will not be in position to continue purchasing more maize due to the financial limitations enumerated above," he said in his submissions.

The board opened its stores for purchases in January when market prices were as low as Sh1,800 per 90 kilogramme bag at farm gate. Kimote said NCPB entry price was set at Sh2,500 in compliance with the directive issued on October 14, 2020 by the government.

"Later the price was reviewed upwards to Sh2,700 per 90kg bag to align to the market forces and has remained the same to-date," he told the committee chaired by Embu Senator Njeru Ndwiwa.

The NCPB increased the prices mid-January, setting the stage for competition for maize in the market.

Hospitality sector pins hope on vaccine, gears up for stronger growth

TOURISM: Kenya's hospitality industry is projected to grow by between 15 per cent and 20 per cent mainly due to the arrival of coronavirus (Covid-19) vaccine in the country.

Going forward, industry players believe the sector will witness improved bookings and accommodation in most establishments, particularly at the coastal region. The sector was hit hard by the pandemic.

Hasnain Noorani, Pridem Group managing director said the vaccine is expected to be a significant boon for the tourism and hospitality industry, which has been badly affected by border closures, travel restrictions, curfew and social distancing measures related to Covid-19.

"We predict an increase of between 15 per cent to 20 per cent bookings and accommodation," he said.

Despite the expected rebound, stakeholders still predict that 2021 will still be a rough year for travel and hospitality industries and full recovery could be a year away.

Clear sign

"There have been an increased number in bookings and reservations in the last few weeks since the vaccination landed in the country, it is a clear sign that things are gradually bouncing back," said Immaculate Wanyonyi, Tourism manager with Hidden Gem adventures.

The vaccine's arrival has raised hopes of a quick re-

covery from both the health-related challenges and the economic impacts of the pandemic.

While a vaccine will be key to any resumption in mass tourism, industry players say that other measures will also be crucial to the expected recovery, amid rising cases of new variants of the infection.

"I believe that the main priority of the tourism industry is to get people travelling and doing business and events again safely by giving government confidence that systematic Covid-19 prevention measures are possible and reliable prior to having a vaccine," Victor Shitakha, Chairman, Kenya Coast Tourism Association

Movement restrictions

Although the situation eased with withdrawal of movement restrictions, many parts of the world are now experiencing a spike in coronavirus cases, leading to further lockdowns.

"As we all know, the vaccine programme will take a while to roll out to all parts of the country, so pre- and post-vaccine programmes should be concurrently available," added Shitakha.

In addition to the fiscal constraints on households, some tourism-related companies may find it difficult to return to business after spending much of 2020 and 2021 either closed or operating severely below capacity.

Jambojet, KTB team up to boost domestic tourism

STRATEGY: Regional low-cost carrier Jambojet has entered into a partnership with the Kenya Tourism Board (KTB) to promote domestic tourism. The partnership involves branding one of Jambojet's De Havilland Dash 8-400 aircraft for a period of one year.

"Last year we launched the 'Now Travel Ready' campaign to encourage domestic tourism as part of Covid-19 recovery. This partnership with KTB will further drive this conversation in a bid to revive the sector," said Karanja Ndegwa, Acting Managing Director, Jambojet.

The move is also part of Jambojet's recovery strategy where it is looking to diversify its revenue generation through advertising placements. Domestic tourism accounts for over 70 per cent of the travel and tourism sector in major economies globally. In Kenya, domestic tourists' bed-night occupancy accounted for

more than 50 per cent of the total bed occupancy from 2015-2018.

Betty Radier, KTB CEO lauded the local carrier for having contributed to the growth of tourism by enabling accessibility to tourism destinations in the country.

She said the partnership was among the many ventures the board has explored with a view to growing the destination tourism offerings. Oxford Economics and global Travel report (2020-2021) data shows domestic and regional travel will dominate the tourism industry in 2021 compared to international tourism. Many destinations are expected to maintain their international travel restrictions for a large part of the year and affordability and safety concerns are also expected to encourage closer-to-home travel.

Kenya skips G-20 debt payment deal

Treasury has opted to pursue market financing in lieu of trying to restructure its borrowing under G-20 framework

Kenya failed to take advantage of a more comprehensive debt payment pause offered by the Paris Club and G20 despite its biting debt problems, global rating agency S&P has warned.

Common Framework for Debt Treatment (CFDT) is a comprehensive arrangement over and above the first Debt Service Suspension Initiative (DSSI), which Kenya had earlier ignored, but later gave in to International Monetary Fund (IMF) pressure.

The new comprehensive arrangement had been designed to be country specific and would also involve the private sector which includes Euro-bond holders.

"So far Kenya has not requested further relief under the more recent and more comprehensive Common Framework for Debt Assessment, also being led by the Paris Club and G20, which aims at more comprehensive debt relief than what is available under the DSSI," S&P observed.

Eurobonds are perhaps the biggest risk in Kenya's foreign debt portfolio given that they come with strict conditions and tend to hold countries at ransom when repayments are required.

Bilateral relief

Analysts had warned that the six month grace period was too short and the government will not be in a position to service the debt.

In January 2020, Kenya secured a debt payment pause from bilateral lenders amounting to savings of about \$550 million (Sh60 billion) under the G20 and Paris Club's Debt Service Suspension Initiative (DSSI).

"While receiving bilateral debt relief, it left private-sector commercial obligations such as Eurobonds unchanged," the S&P report said in part.

Treasury Cabinet Secretary Ukur Yatani said Kenya did not want to get debt relief because of fear that the country's credit rating could suffer while private bondholders could become jittery.

US financial news publisher Dow Jones noted that Kenya and other countries in the region could resort to broad based tax hikes to cover rising deficits.

"Further significant deteriorations in public finances

triggered by stricter COVID-19 containment measures could push markets closer to debt distress. This would curtail government spending and likely result in faster-than-planned tax increases targeting consumers and local businesses," said Dow Jones in its 2021 Global Leadership Briefing.

Kenya's external debt is now at Sh3.7 trillion with a total public debt at Sh7.3 trillion by end of last year. S&P warns that Kenya's stock of general government debt net of liquid assets will rise to an average of 66.5 per cent of GDP in 2021-2024, from 52.5 percent in 2019 and 37.7 per cent in 2015.

Guaranteed debts

Debt servicing costs will increase and average a high 27 per cent of general government revenue in 2021-2024 says the ratings agency.

"Debt eligible to the treatment will include all public and publicly guaranteed debts which have an original maturity of more than one year," the Paris and G20 countries noted in the Common Framework for Debt Treatment.

"The treatment necessary to achieve sustainability will take into account the cut-off date in the 2020 DSSI term sheet that protects new financing provided after 24 March 2020."



DEBT MANAGEMENT

● Kenya may be in the market for funds through international capital markets later this year if it does not secure enough low-priced funds from lenders like the World Bank.

● The government may also use new sovereign bond issuance to refinance maturing debt and manage its liquidity and liability.

● Under those deals, which fall under the G20's poor nations debt relief deals, Kenya is deferring payments worth \$600 million.

Michelle unsurprised by Meghan race talk

Former US First Lady Michelle Obama said she hoped there would be "forgiveness"

Former US First Lady Michelle Obama has said it "wasn't a complete surprise" to hear the Duchess of Sussex talk about race in a recent TV interview.

Obama spoke to NBC's Today show about Meghan and Harry's interview with Oprah Winfrey.

Meghan and Harry had opened up about a range of personal topics, including racism and mental health.

Meghan said Harry had been asked by an unnamed royal family member "how dark" their son Archie's skin might be.

Buckingham Palace said the race issues raised by Meghan, 39, and Harry, 36, were "concerning", and would be "taken very seriously" and dealt with privately.

In her interview with NBC, Obama was

asked what had gone through her mind while watching Meghan's candid conversation with Oprah.

"Public service is a bright, sharp, hot spotlight," said Obama, who spent eight years in the White House while her husband, Barack Obama, was US president.

"And most people don't understand it, and nor should they. The thing that I always keep in mind is that none of this is about us in public service, it's about the people we serve."

Experienced racism

Obama, 57, was asked about the moment Meghan told Oprah she had "experienced racism".

"As I said before, race isn't a new construct in this world for people of colour, and so it wasn't a complete surprise to hear her feelings and to have them articulated," Mrs Obama replied.

In a separate interview with Access Hollywood, Mrs Obama said she hoped

Meghan and Harry would find a way to reconcile with the royal family.

"My hope is that, when I think about what they're going through, I think about the importance of family, and I just pray that there is forgiveness, and there is clarity and love and resolve at some point in time," Obama said.

The former first lady is a long-time supporter of Meghan, calling her a "friend" and "inspiration" in a 2019 Instagram post.

Harry has been friends with the Obamas for years, forming a bond over charity initiatives. The Obamas were early supporters of Harry's Invictus Games Foundation.

Meghan interviewed Obama for an edition of British Vogue she guest-edited in 2019.

For this project, the Duchess said she had enlisted the help of Mrs Obama, describing her as an "endearingly frank, down-to-earth" person.

Seven killed in south-western Pakistani coal mining disaster

At least five coal miners and two rescuers have died of suffocation after a methane gas fire in the southwestern Pakistani province of Balochistan, officials say. The fire took place at a mine in the Tor Ghar area of Harnai district, about 170km (105 miles) west of the provincial capital Quetta, late on Monday, said government official Sohail Anwer Hashmi. "The coal miners entered inside the mine to fill the cracks

caused by [the] fire, but they died of asphyxia caused by the deadly methane gas," Hashmi told Al Jazeera by telephone. "The coal miners were working 1,400ft (427m) deep inside the mine when the incident [was] reported," he said. The seven miners' bodies were recovered after rescue operations through the night, Hashmi said. The accident was the second coal mine disaster in Balochistan within days. - AFP

Protesters storm presidential palace in Yemeni city of Aden

Angry Yemeni protesters have stormed the presidential palace in the southern city of Aden – seat of the internationally recognised government – according to local sources. Demonstrators broke into the Maasheeq Presidential Palace on Tuesday amid public anger over the lack of services, poor living conditions and depreciation of the local currency, the sources told Reuters. Local sources also told Al Jazeera the

protesters found no resistance from forces loyal to the UAE-backed Southern Transitional Council. Al Jazeera's Jamal Elshayyal said the protesters are members of the national security forces who have not been paid for nine months. "We understand the protests have been peaceful so far and that some sort of mediation is taking place," Elshayyal said, speaking from the Qatari capital, Doha. - AFP

Tanzanians demand accurate information on missing President

Tanzanians are now demanding to see their leader, President John Magufuli, right, in person. After days have turned into weeks locals say his presence will end the rumour mongering and reassure the country that he is doing fine.

Zitto Kabwe, the leader of opposition party ACT-Wazalendo, said the government was merely giving room for panic.

"We know for sure that the president is ill but we are surprised by the deepening silence about the matter," he said in a statement Tuesday.

"We need to know who is currently heading the government through which constitutional powers."

"I believe something is happening but the authorities are hiding," said Muhsin, a resident of the financial capital Dar es Salaam.

"I will be comfortable if I see the president himself." Clothes vendor Deborah said there was "unnecessary secrecy".

"If our beloved president is really ill, they should tell us the truth so that we put him in our prayers," she said.

On Friday, Prime Minister Kassim Majaliwa said Magufuli was "strong and working as usual".

On Monday, vice-presi-



dent Samia Suluhu Hassan dropped a possible hint the president is ill, without naming him.

"Our country is now full of rumours from outside but that should be ignored... It's quite normal for a person to contract flu, fever or any other disease," she said.

"If there's need for us to remain united, the time is now."

Magufuli came to power in 2015 as a no-nonsense, corruption-busting president nicknamed the "Bulldozer", and was re-elected in a disputed poll last year.

However he has been accused by rights groups and of stifling democracy, and cracking down on the media.

As a result, the country's journalists are too afraid to dig into the story.

"It's all about survival and telling the truth... you need to play it safe," an editor said.

"Put down that controller!" "Stop fiddling with your phone!" "You can't play that video game right now, you've got homework to do". These are some of the refrains that you have probably heard many times in your lives.

Ten... Ways to enhance your vehicle's fuel efficiency

On Monday this week, motorists woke up to depressing news from the Energy and Petroleum Regulatory Authority (Epra) over the increase of fuel prices with a litre of super petrol going up by Sh7.63 while the price of a litre of diesel and kerosene shot up by Sh5.75 and Sh5.41 respectively. The motorists are feeling helpless, especially now that Covid-19 has also eroded the economy. With the price reduction not expected any time soon, it's worth thinking about how to use less fuel. **Allan Adalla** shares tips to ensure fuel efficiency when driving

1. The AC and open windows dilemma

We are in the hot season where the car interiors get really heated up, leading to uncomfortable temperatures. So, do you roll your windows down or switch the air conditioning on while trying to keep your car cool? Well, these methods of attaining an ambient temperature are not advised as they contribute to high fuel consumption. Air conditioning uses fuel, and having the windows down causes drag or air resistance, so it needs to use more energy to push air out of the way as it cruises.

2. Inflate tyres to correct pressure

Each tyre size has a specific pressure quantity. Most passenger cars will recommend 32 PSI to 35 PSI when the tyres are cold. For the most accurate reading, make sure the car has been sitting overnight or has been parked for a few hours. The more surface area in contact with the road, (in the case of under inflation) the more drag on the wheel and this will increase the consumption of your car.



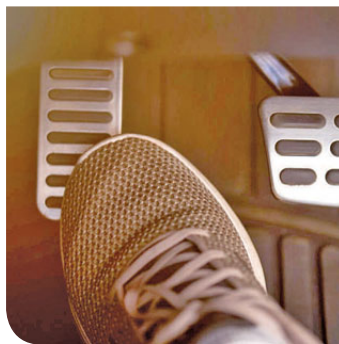
3. Drive only when needed

The best way to reduce fuel consumption is to simply drive your car less. Drive your car only when you really need to. If you only need to travel a few blocks, consider walking or even riding a bicycle. Not only will you save money at the pump, the exercise will certainly do you some good instead of staying seated in the car.



4. Plan ahead for your trip

Before commencing on a journey, it is advisable to know the distance you are about to cover and the petrol stations you will meet along the way. This will help you plan when to refuel and where you will go to do so. For instance, super petrol is now retailing at Sh115.18 per litre in Nairobi while in Mombasa and its neighbouring counties it is retailing at Sh112.78. It would be cheaper to fill the fuel tank in Mombasa than in Nairobi. It will also help you avoid panic-buying at the nearest, most expensive station.



5. Be soft to the accelerator

Drivers always have different preferences on revving the car; some prefer going hard on the accelerator for high speed while others opt for gentle acceleration and calm driving. According to experts, it is advisable to maintain gentle acceleration and use the highest safe gear in order to use less fuel. This is known as 'eco-safe driving'. However, this becomes more applicable to the manual transmission cars where the driver has the liberty to engage the gears. What's more, when you approach traffic lights, ease off the accelerator early if the lights are red.

6. Avoid prolonged idling

Running your engine at a stop consumes roughly 1.8 litres to about 3.7 litres of fuel every hour. It also degrades the surroundings through carbon dioxide pumped into the atmosphere. This means you're burning about 30.2 grammes to 63 grammes of fuel every minute you're idle. With modern cars being more efficient nowadays, you're likely to burn less fuel by simply turning off your engine, then restarting it when you have to move again. This will help you save energy in the common Nairobi traffic.

7. Don't coast

On the bygone car technology, it was a norm to save fuel by coasting – travelling either with the clutch pedal held down or with the car in neutral. Well, in modern cars, indeed, it won't cost you extra, but it won't save you fuel either. That's because when you take your foot off the accelerator in a modern car the fuel supply to the injectors is cut, so there's nothing to be gained. Therefore, you're much better off altering your driving style, than trying to improve fuel efficiency by coasting.

8. Maintain your engine

Whenever you realise that your car engine consumes fuel more than it does normally, don't hesitate to examine it. Looking after your engine will not only help improve fuel economy, but is important for safety and the longevity of your vehicle. According to experts, having your car properly tuned can improve fuel kilometre by up to four per cent and using the correct oil is good for up to two per cent.



9. Monitor your car

For the time I have spent with my car, I know that it consumes one litre of fuel per 10 kilometre. If the car shows the fuel warning light before covering this distance, then this clearly shows me that the car has a problem. You should also take a keen note on knowing your car fuel efficiency. Measuring fuel economy helps you see if making changes to your driving has a considerable effect on your fuel gas mileage.

10. Reduce weight in the vehicle

Get rid of any unnecessary items in your car's trunk or other areas of the vehicle to make the car lighter. For every 50 kilogramme of weight in the vehicle, your car's fuel economy decreases by about one or two per cent. By making sure your vehicle remains as light as possible, you can improve the fuel consumption of your vehicle and save money on your fuel bill. Having unnecessary weight in your vehicle wastes fuel, particularly during acceleration. If there is heavy stuff in your boot that you don't need, leave it behind or ditch it.

Shielding children from the snare of advertising

Every other day, thousands of children across the country, and the world, are exposed to different kind of adverts, which appear on different platforms — from TV, radio, YouTube, billboards, magazines, newspapers, movies/series, online games, the internet, social media and many others.

According to the American Psychological Association, an average child is exposed to more than 40,000 TV commercials a year. Advertisers, especially target younger children because they are naive and the easiest to persuade. Studies have shown that from the age of three, children can differentiate between brands and logos, which later on cement them as loyal customers for their preferred brand or logo.

Children represent an important demographic to marketers because they influence their parents' buying decisions and are the adult consumers of the future. Psychologists argue that when you target adverts at children, and create that desire in them to have your product, they use 'pester power' to get their parents to buy the desired product.

"Pester power" refers to children's ability to nag their parents into purchasing items they may not otherwise buy.

Providing alternative

Psychologist John Mark Otieno says advertising may have negative effects on children such as provoking alcohol consumption and smoking of cigarettes, cause eating disorders, make them develop materialistic feelings (consumerism), beguiles children to try dangerous stunts, provoke violence and aggressive thoughts, among others.

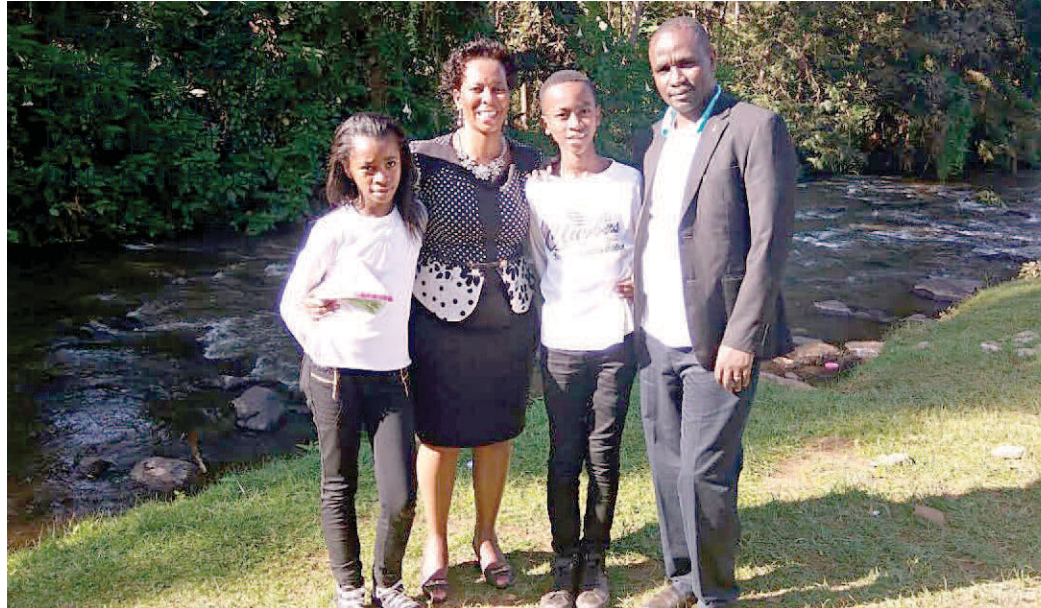
Just recently, the International Children's Day of Broadcasting was celebrated across the world with calls for broadcasters around the world to pay more attention to children's programmes, air quality programmes for children and most importantly, allow children to be part of the programming process.

During a virtual event that was held to mark the day, it became apparent that children under three years of age are sometimes exposed to content that is not appropriate and child friendly, but just for profit.

"There is serious shortage of age-appropriate media," said Lynette Okengo, from the Africa Early Childhood Network who spoke during the virtual event.

Karago Kabura, a parent of two teenagers aged 19 and 16 years says in as much as some advertisements are educative and informative, others are not, hence parents need to limit their children's exposure to advertising. "The best way to tame children from watching too much advertisement that doesn't enrich their knowledge is simply to have them engaged in other activities that are equally interesting and capture their attention," says Kabura.

"Children get attracted to these adverts because most of them are usually short with catchy phrases and eye-catching. This is what gets them glued to TV screens. You will even hear some children repeat word for word the phrases or lyrics to a song in an advert. If one is to take away the attention of the children from the TV, they must in return provide another means, which should and must be



equally captivating than what is on the TV," she explains. According to Kabura, in this era of advancement of internet and other social media platforms, it is important for parents to involve their children in activities that are mind involving, interesting and creative. These activities must also not be too repetitive as children lose interest fast.

Susan Catherine Keter, a transformational life coach says the brains of children below school age are not developed enough to tell the difference between fantasy and reality. Yet advertising is more of fantasy, with high gear persuasion. "At that age, children's brains have not developed critical thinking or the ability to analyse issues and question things. Their brains absorb like a sponge. The information they absorb goes to form their deep-rooted value systems, something they will not be consciously aware of even later in life," says Keter.

Dangers abound

She offers: "They will be vulnerable to bad choices such as opting for junk foods, which are high in calories yet low on nutrients because at the sub-conscious level they believe that such foods are for people of class. Girls who watch advertising from a young age where certain looks are glorified (thin girls,

light skinned, with long silky hair) are likely to develop negative body image and self-esteem issues and could unconsciously opt for procedures such as bleaching of the skin and body enhancement procedures in an effort to match the image of beauty that is buried deep at the subconscious level."

She advises parents not to trust content at face value just because the label indicates that it is appropriate for a particular age. "Watch it and decide if it is appropriate for your young child or not. For older children, you can talk to them and critically analyse some adverts and their intended purpose," she says.

As a parent, it is also important to talk to your child about protecting his or her online privacy. Children give advertisers a lot of information just by downloading an app. Social networking sites such as Facebook and Twitter are conjuring up ways to make money off the behavioural data they can collect on children.

Marketers use different techniques to appeal to children. "Advertising is subtle nowadays, hidden even in cartoons and computer games, hence be slow to trust any content based on what the label indicates," Keter adds.

Brands appealing to teens take advantage of their particular vulnerabilities: the desire to fit in, to be perceived as attractive, and to not be a huge dork. Teens are extremely at-

tuned to their place in the peer hierarchy, and advertising acts as a kind of "super peer" in guiding them toward what's cool and what's acceptable.

Others appear in form of bribe. For example, you get a free toy when you buy a product. There are also games where you play and win a prize if you buy a product. Others use catchy tunes, repeat the ad over and over again so that it makes it difficult to forget it or tell an interesting story or joke.

Careful guidance

Sex is used in commercials to sell everything from beer to food and cars. New research is showing that teenagers' exposure to sexual content in the media may be responsible for earlier onset of sexual intercourse or other sexual activities.

Gospel artiste Princess Farida says there is need for guidance and supervision from the parents on the kind of content their children watch and are exposed to.

"We carefully review and select what our children watch on TV. For example, we do not allow our children to watch adverts of certain products such as cigarettes, alcohol or condoms. But if it's an advert that bears a good message, then why not let them be informed," says Farida.

Farida and her husband have learnt to help their children strike a balance between school work and other co-curricular activities.

"If they get opportunities to appear in adverts, we don't stop them. We are always present, working with producers and supporting our children by helping them memorise their lines and act it out like professionals. We have signed them with reputable firms and organisations," Farida says.

LIMITING COMMERCIALS

● While you can't protect your child from preying advertisers entirely, you can help them limit their privacy vulnerabilities and cultivate a healthy sense of skepticism towards advertising.

● If your child has a favourite programme on commercial TV, consider subscribing to a streaming service, so your child can watch it without advertisements. You could also consider paying a bit more to avoid advertisements on YouTube or to get ad-free versions of apps.

● To limit the effects of advertising on school-age children, the most important thing you can do is talk about advertisements and encourage children to think about what they're trying to do.

● It's a good idea to focus on the advertisements that your child sees most often. For example, you can get your child to develop a questioning attitude towards advertisers' claims by asking him to think about what's being advertised. That is, what's the product in this advertisement? What is it for? Who is it for?

● You can also ask your child about the strategies that are being used to sell a particular product. This can help your child work out how an advertisement makes a product look good.

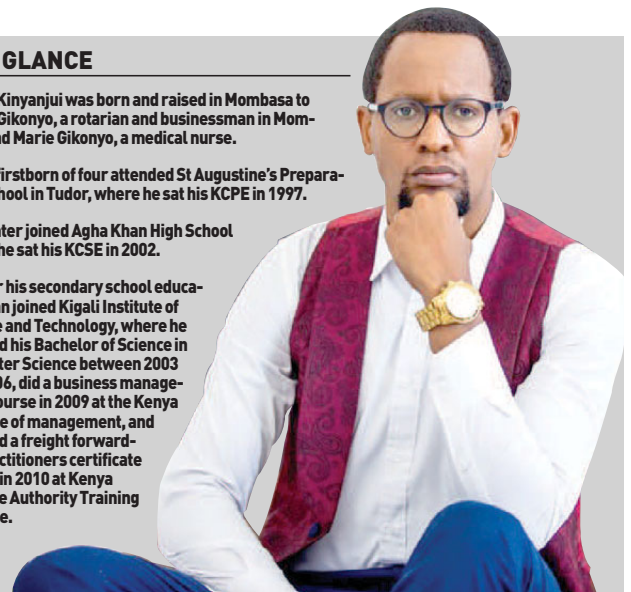
"We have so many memorable moments; When he asked me to marry him, when our boys first called me mum, when we started

Harvard prof ignites anger over 'comfort women' claim

A Harvard University professor has ignited an international uproar and faces mounting scrutiny for alleging that Korean women who were kept as sex slaves in wartime Japan had actually chosen to work as prostitutes.

In a recent academic paper, J. Mark Ramseyer rejected a wide body of research finding that Japan's so-called "comfort women" were forced to work at military brothels during World War II. Ramseyer instead argued that the women willingly entered into contracts as sex workers.

His paper has intensified a political dispute between Japan, whose leaders deny that the women were coerced, and South Korea, which has long pressed Japan to provide apologies and compensation to women who have shared accounts of rape and abuse.

Decades of research has explored the abuses inflicted on comfort women from Korea and other nations previously occupied by Japan. In the 1990s, women began sharing accounts detailing how they were taken to comfort stations and forced to provide sexual services for the Japanese military.

Hundreds of scholars have signed letters condemning Ramseyer's article, which united North and South Korea in sparking outrage. Last Tuesday, North Korea's state-run DPRK Today published an article calling Ramseyer a "repulsive money grubber" and a "pseudo scholar."

Ramseyer, a professor of Japanese legal studies at Harvard Law School, declined to comment.

Ramseyer's article, titled *Contracting For Sex In The Pacific War*, was published online in December and was scheduled to appear in the March issue of the *International Review of Law and Economics*. The issue has been suspended, however, and the journal issued an "expression of concern" saying the piece is under investigation.

Most alarming to historians is what they say is a lack of evidence in the paper: Scholars at Harvard and other institutions have combed through Ramseyer's sources and say there is no historical evidence of the contracts he describes. In a statement calling for the article to be retracted, Harvard historians Andrew Gordon and Carter Eckert said Ramseyer "has not consulted a single actual contract" dealing with comfort women.

"We do not see how Ramseyer can make credible claims, in extremely emphatic wording, about contracts he has not read," they wrote.

Black tax: To pay or not to pay?

Should helping out your family members come at the expense of your personal growth and advancement?

Times are hard. By June 2020, over one million people had lost their jobs due to the coronavirus pandemic and its constriction of the economy. While some people had emergency funds to tide them over as they looked for new jobs, most people did not. What followed is a quick downsizing of cars, houses and sale of anything disposable. One would think this would just be felt by the now unemployed populace, but the ripple effect of the job losses was felt all the way to the villages.

A tax for blessings

John (not his real name), lives in a two bedroomed apartment in Jamhuri. He lives with his cousin, whom he took through a tertiary institution and currently works as a mechanic understudy, and his younger brother who is still in university. Despite having lost his job as a banker due to Covid-19, his cousin, brother and their relatives in the countryside still expect him to support them. He is still sending monthly upkeep money for his parents while dreading any emergency call asking for any money to pay a hospital bill.

John, currently working as an Uber driver with a car he had bought while employed, says he is scared of the future as he cannot fathom continuing to live a life where he cannot even afford to invest due to the weight of responsibilities. He, however, believes he is all the family has as he is the first one to go to university. His parents sold a huge chunk of land to take him through school and he, therefore, feels he owes them.

John reveals he is envious of friends who are able to put themselves first and stop paying the black tax, despite seeing them as selfish and knowing he could never do it.

By definition, black tax is income black professionals give to their families to support them.

"It has always been the duty of the young to take care of their elders in the African community. People would take pride in cooking for, cleaning and providing for their elders. Among the Agikuyu, for instance, the last born son was supposed to inherit the hearth and was the one who would take care of their parents in old age. He would stay in the parents' compound in his own hut, marry, with his wife cooking for his parents as they aged and his children being sent on errands by grandparents.

In some cases, the eldest son would take up the onus of caring for the parents. Other sons and daughters were free to visit and chip in whenever they had time. This cycle would continue from one generation to the next," Dr Francis Kerre, a sociologist and don at Kenyatta University explains.

He says even slightest thought of not helping out elders in favour of personal progress was unheard of. One was expected to help not just their own aging parents, but their aging relatives as well. It was one way of earning blessings of a long life, good health and wealth.

However, while severing ties with the aging population is unheard of, more and more millennials are choosing themselves over their families. They are choosing to invest in their futures rather than pour all their earnings back to their families as society expects.

"It is okay to help out your less fortunate relatives. But you also have to think about your future and if you will be the one forcing

others to pay black tax. Save up and have an emergency fund and a sinking fund. An emergency fund is saved funds for an unplanned expense while a sinking fund is money saved for a foreseen expense such as a water tank for parents back in the rural home or their health insurance payment," Susan Wanjiku, a financial advisor and founder of The Legacy Hub Kenya explains.

Balancing act

She adds, "No one talks about retirement and how to prepare for it. It is erroneous to think that you will be young forever and that you will always be able to work and earn a living. Start saving and investing for retirement. Work on having a passive income big enough to envision the lifestyle you would like once you have retired. This is the only sure way to break the black tax cycle and ensure that we do not become a burden to our children or our relatives in old age."

She insists on need to balance supporting relatives with investing in oneself. She emphasises that no one specific rule fits all when it comes to this. It is all discretionary. It is up to the person with the money to decide whether to give back to the family or not to. She, however, insists on the importance of boundaries to stave off overzealous relatives who might take one for all they have got.

"For boundaries to work, one needs to communicate clearly and concisely in order not to sever the relationship while ensuring they do not take up more than they can handle. Communicate whether the help is a one-off to manage expectations. Opt to start something that would give your relatives income rather than them having to depend on you for handouts. Decide who, when and where to show up not just for your relatives but for yourself. At the end of the day, you are the one in charge. Do not just complain about black tax, apply wisdom and take back the control," she says.

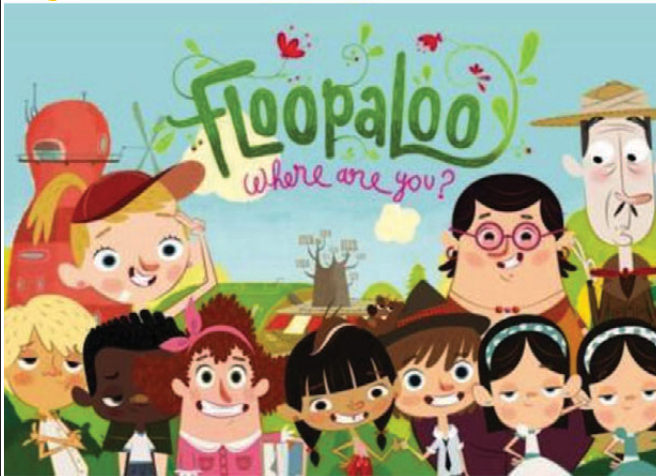

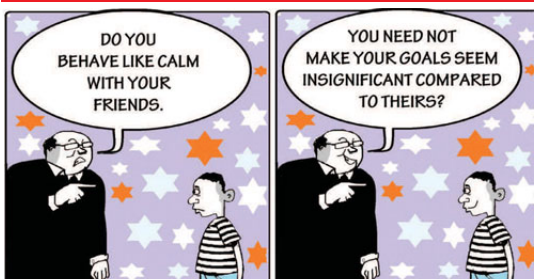

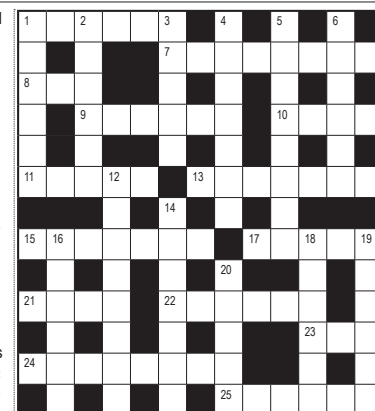

The team is currently in North Rift to visit places where a team of selected athletes can be put in camp to have them train with the aim of hitting the Olympic qualifying marks during the remaining one weekend meeting.

The team will visit Eldoret in Uasin Gishu County, then go to Kapsabet (Nandi County) and Iten and Kaptagat in Elgeyo Marakwet County to survey facilities and file a report to AK tomorrow (Wednesday) for the federation to

pick one place where the selected athletes will assembly as soon as possible.

The Mutwii, Chemos and the coaches committee, sources said first met on Friday at Nyayo stadium during the first day of the weekend meeting where the senior vice president expressed the Federation's concern that at the moment, Kenya has no medal prospects in men 5,000m and 10,000m in Tokyo.

The last men 5000m gold was won by John Ngugi in the 1988 Seoul, Korea Olympics while the only 10,000m gold ever for Kenya was won in 1968 by Naf-tali Temu in the Games held in Mexico.

Tokyo Olympics challenges

Officials say current proposed bubble to prevent athletes from contacting Covid 19, is a lame duck without any effect, call for fresh thinking

National Olympic Committee of Kenya (NOC-K) yesterday revealed the concept of a bubble training camp in Kenya is far from being perfect.

In a candid assessment, Tokyo Olympics Games Chef de Mission Waithaka Kioni and Barnaba Korir, Team Kenya's general team manager to the Games laid bare the challenges

they are facing even as Kenya team enters week three of bubble camp at the Stadion Hotel, Kasarani.

Kioni said the move that was meant to keep the sportspersons safe and healthy in preparations for the Games is facing several obstacles, in the Kenyan instance.

"Managing athletes in a bubble camp in our situation in Kenya has not been easy. Because that concept means you put your athletes and their

support in a bubble with limited or no interactions with other parties. But the situation here is very different because the athletes are in camp at Kasarani, a government facility, that is also accommodating other people, the athletes are being served by employees of Sports Kenya who are not residents of that facility," Kioni explained yesterday.

The Nock executive member said the body is trying to do their best but warned it might not be enough.

A reckless Kenyan culture that is also being exhibited by the athletes is another challenging factor as cited by Kioni.

"Everyone even the President Kenyatta is insisting on the strict following of Covid-19 protocols adherence. Social distancing, washing hands and wearing face masks. But in reality you know what is happening. There is kind of careless attitude unfortunately extends to our own athletes," Kioni said while aiming a dig at the athletes for their unwarranted movements in and out of camp.

The bubble camp was opened for Team Kenya squads preparing for the Tokyo Olympic Games.

According to Korir, track and field athletes were the first in camp after going through pre-camp screening and were joined by the volleyball and rugby teams.

That, Kioni said, is a fact that the situation is not easy to manage.

Will Luis 'bite' the Blues?

Atletico look to Suarez for inspiration in Chelsea rescue mission

Atletico Madrid's hopes of coming back against Chelsea in the Champions League on Wednesday may depend on Luis Suarez (pictured) returning to form on his return to the country where he became one of the best in the world.

Atletico trail 1-0 after Olivier Giroud's bicycle kick lit up an uneventful first game at the Wanda Metropolitano last month and handed Chelsea a crucial advantage heading into this week's second leg.

And if they are to reach the quarter-finals with another upset like the one that knocked out Liverpool last year, Atletico are likely to need Suarez back to his best at Stamford Bridge. The Uruguayan's form has matched his

team's, with a slight downturn in recent weeks perhaps inevitable after such an impressive first half of the season.

Suarez scored 16 goals in his first 21 games while Atletico lost only one of their first 20 in the league, when a first La Liga title since 2014 seemed firmly within their grasp.

Yet they have won only three of their last eight and Suarez has scored only twice in that time, even if those two goals have come in the last three, against Real Madrid and Athletic Bilbao.

Certainly, there can be no room for complacency for Chelsea, who know only too well the damage Suarez can do after his hugely successful four seasons for Liverpool, when he scored 82 goals in 133 appearances.

"He is a natural-born striker," said Chelsea coach Thomas Tuchel before the first leg. "He has that certain mentality that only strikers have. This mentality to show his will, intensity and anger to score and score and score and is never satisfied. What a mentality, what a player."

Tuchel is such a fan he even tried to sign the 34-year-old for Paris Saint-Germain when it became clear he was on his way out of Barcelona last summer.

"There was a possibility," Tuchel said. "We heard the rumours he was about to leave Barcelona and who cannot be interested to sign one of the best strikers in world football, in history and the present?"

"We tried our luck. We did not make it, he chose to stay in Spain with Atletico and again he proves his quality."

Suarez has history with Chelsea too, after one of his three biting incidents happened while playing against them for Liverpool in 2013, with Branislav Ivanovic that time the victim.

But without fans in the stadium and with a fresh crop of players, Chelsea will be focused completely on thwarting Suarez's threat to their goal while the striker will be hoping to end his own six-year wait for a Champions League goal away from home.

"For all the competitions, not just the Champions League, his presence gives us experience and leadership," said Atletico coach Diego Simeone last month.

"He brings confidence to our team and a lot of tension for our opponents because history shows this is a player who has a gift around the goal."

Suarez's 18 goals in 29 games this season means his switch to Atletico from Barcelona last summer has already been a triumph but there will be disappointment now if he does not end the season with a trophy.

Despite their dip, Atletico remain four points ahead of Barca in La Liga and it might be that a defeat to Chelsea could help their La Liga ambitions, with the Catalans being knocked out of the Champions League last week by Paris Saint-Germain.

Suarez will not relent. "My way has always been to be competitive, always wanting to prove myself," he said earlier this month.

"To come to a team like Atletico that hasn't won titles for a long time, to be able to win something is definitely one of the wishes I have."

Members of Japan's 2011 World Cup-winning squad are due to use the Olympic flame to light the torch at the start of the nationwide relay in Fukushima. "Once again, I have declined to be a torch runner on March 25, 2021," tweeted Kawasumi, who was part of the team that stunned the US to win the 2011 final. -AFP
